1 On February 9, 2012, CWA, Inc., d/b/a Airporter Shuttle, filed an application in Docket TC-120188 with the Washington Utilities and Transportation Commission (Commission) under RCW 81.68.046, for temporary authority to provide service as a passenger transportation company. The service requested is as follows:

PASSENGER SERVICE BETWEEN Yakima, Ellensburg, Cle Elum, and ***North Bend***

PASSENGER SERVICE BETWEEN Yakima, Ellensburg, Cle Elum, and ***North Bend*** on the one hand and on the other hand to Seattle-Tacoma International Airport and the Seattle Amtrak Station.

NOTE: This Order grants, on a temporary basis, that North Bend is added to CWA, Inc. Certificate C-1073.

2 The Commission, having considered the application and being fully advised, finds that the applicant is fit, willing, and able to provide the proposed service. Further, the Commission finds that in view of the existing circumstances, the issuance of a temporary passenger transportation company certificate is consistent with the public interest; and that it would be in the public interest to grant the application.

3 The temporary authority granted by this Order is subject to protest for 20 days from the date published by the Commission on the application docket.

ORDER

THE COMMISSION ORDERS:

- 4 (1) The application filed by CWA, Inc., d/b/a Airporter Shuttle, in Docket TC-120188 is granted in conditioned upon compliance with the laws and rules relating to passenger transportation companies, and that a certificate be issued to CWA, Inc., d/b/a Airporter Shuttle, authorizing the carrier to operate as a temporary passenger transportation company providing service as described in Appendix A.
- 5 (2) This temporary certificate will expire automatically, by operation of law and without further Commission action, when (1) the Commission enters an order approving withdrawal of the application in Docket TC-120188, or (2) the Commission enters an order granting an application for permanent extension of authority. If the Commission denies, dismisses, or grants less than all of the permanent application, this temporary certificate will terminate on the last day for seeking judicial review of the Commission decision or, in the event of judicial review, on any later date that the reviewing court may order.
- 6 (3) The tariff and time schedule for CWA, Inc., d/b/a Airporter Shuttle, filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this Order.
- 7 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(6)(a).

NOTICE: This is an order delegated to the Secretary for decision. In addition to serving you a copy of the decision, the Commission will post on its Internet Web site for at least 14 days a listing of all matters delegated to the Secretary for decision. You may seek Commission review of this decision. You must file a request for Commission review of this order no later than fourteen (14) days after the date the decision is posted on the Commission's Web site.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.

PASSENGER SERVICE BETWEEN Yakima, Ellensburg, Cle Elum, and *North Bend* on the one hand and on the other hand to Seattle-Tacoma International Airport and the Seattle Amtrak Station.

NOTE: This Order grants, on a temporary basis, that North Bend is added to CWA, Inc., Certificate C-1073.

This temporary certificate will expire automatically, by operation of law and without further Commission action 180 days following its effective date. The expiration date is August 11, 2012.

If the applicant files a parallel permanent application within 30 days of the grant of this temporary certificate then the temporary certificate will end when (1) the Commission enters an order approving withdrawal of the permanent application, or (2) the Commission enters an order granting the permanent application.

If the Commission denies, dismisses, or grants less than all of the permanent application this temporary certificate will terminate on the last day for seeking judicial review of the Commission decision or, in the event of judicial review, on any later date that the reviewing court may order.
