




Fuel index prices have increased from \$2.36 per gallon for the base period to \$3.6362 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 05 in the amount of 2.10%.

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: March 1, 2012.
2. The proposed changes will expire on: May 31, 2012
3. The temporary 2.10% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of December 2011 and January 2012, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of March 2012 and April 2012.

Customers who are billed bi-monthly for services – two months in advance:

February 2012 (B)	March 2012, and April 2012
March 2012 (A)	April 2012, and May 2012

Customers who are billed bi-monthly for services – current month and one month in advance:

Customers Billed at Month's end in:	Fuel Surcharge applies to all services provided in the months of:
March 2012 (C)	March 2012, and April 2012
