We oppose granting permanent Household Goods Carrier Authority to applicant Friends & Family Moving & Storage, Inc. (Permit No. HG062096).

Reasoning:

- 1. We believe that this carrier's trade name is in violation of WAC 480-15-390 that states:
 - (2) A carrier may not operate under a name that is similar to another carrier unless...
 - (a) The carrier whose name is similar has given written permission to use the name [SUCH PERMISSION HAS NEVER BEEN GRANTED]
 - (b) ...the commission must first determine that the use of the similar name will not mislead the shipping public or result in unfair or destructive competitive practices.
- 2. We believe that this carrier's trade name is in violation of WAC 480-15-390 (2) (a), in that, FAMILY MOVERS (HG-5966) have never "given written permission" to Friends & FAMILY MOVING.

- 3. Common sense reveals the obvious name similarity, and the greater propensity for consumers to be confused and misled.
- 4. We therefore believe that this carrier's trade name is in violation of WAC 480-15-390 (2) (b), in that, the name similarity between **FAMILY MOVERS** and Friends & **FAMILY MOVING** has indeed confused and therefore has "mislead the shipping public or result in unfair or destructive competitive practices" according to customer feedback over the past several years.
- 5. Logic dictates that the Commission would also be in agreement with the above reasoning; otherwise, if it did not oppose granting permanent HHG Carrier Authority to Friends & Family Moving, it would also not oppose Family Movers adding an additional d.b.a. of Family & Friends Movers.

For the above stated reasons, we oppose granting permanent Household Goods Carrier Authority to applicant Friends & Family Moving & Storage, Inc. (Permit No. HG062096).
