Note 1: Rates in this item are subject to disposal fees named in Item 230.

Note 2: Rates named in this item apply for all hauls not exceeding 5 miles measured from the point of pickup to the disposal site. Excess miles shall be charged for at **\$ 2.50** per mile or fraction of a mile. Mileage charge is in addition to all regular charges.

Note 3: Permanent Service:

(a) Minimum service is defined as no less than scheduled, once a month pickup, unless local government requires more frequent service or unless putrescibles are involved.

(b) If rent is shown, the rate for the first pickup and each additional pickup must be the same. If rent is not shown, it is to be included in the rate for the first pickup.

Note 4: In accordance with Douglas County Solid Waste Collection Fee Ordinance C.E. 94-014, the fee shown in each column above will be assessed each month. This fee will expire on **March 31, 2014 (C)**.

Accessorial charges assessed (lids, tarping, unlocking, unlatching, etc.):

Note 5: A gate or obstruction charge of **\$12.90** per pick up will be assessed for opening, unlocking or closing gates or moving obstructions in order to pick up solid waste.
