Pursuant to WAC 480-123-060, Whidbey Telephone Company (“Company”) hereby requests that the Washington Utilities and Transportation Commission (“Commission”) certify to the Federal Communications Commission and the Universal Service Administrative Company that the Company has met the requirements of 47 C.F.R. § 54.314 for eligibility for receipt of federal high-cost funds.

The certifications and reports (“Reports”) that are specified in WAC 480-123-060, WAC 480-123-070 and WAC 480-123-080 accompany this letter of transmittal.¹


