Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revision to the WN U-60, Tariff G for electric service of Puget Sound Energy (the “Company” or “PSE”).

The primary purpose of this filing is to update the amount of cumulative generating capacity available to net metering systems and the amount of that capacity reserved for net metering systems that generate renewable energy in accordance with RCW 80.60.020(1)(a).

This filing also reflects updates to the availability section and to the visible-break disconnect portion of the terms and conditions section to reflect changes to conform with the revisions to WAC 480-108, Interconnection with Electric Generators. Specifically, paragraph 3 of the availability section reflects changes in the percent of generation capacity that can be on a distribution feeder in accordance with WAC 480-108-020 and paragraph 6 of the terms and conditions section has been updated so that a visible-break disconnect switch is not required for Tier 1 interconnections as provided in WAC 480-108-020.
