Description of amendment: Amends the agreement reflecting implementation of the FCC's Intercarrier Compensation Reform Timeline (CC Docket No. 01-92) as provided in the *USF/ICC Transformation Order FCC 11-161 (rel. November 18, 2011)*.

The amendment amends the interconnection agreement first approved by the Commission on August 16, 2006 in WUTC Docket No. UT-063054.



The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
