MAP OF EXCHANGE AND TOLL STATION AREAS

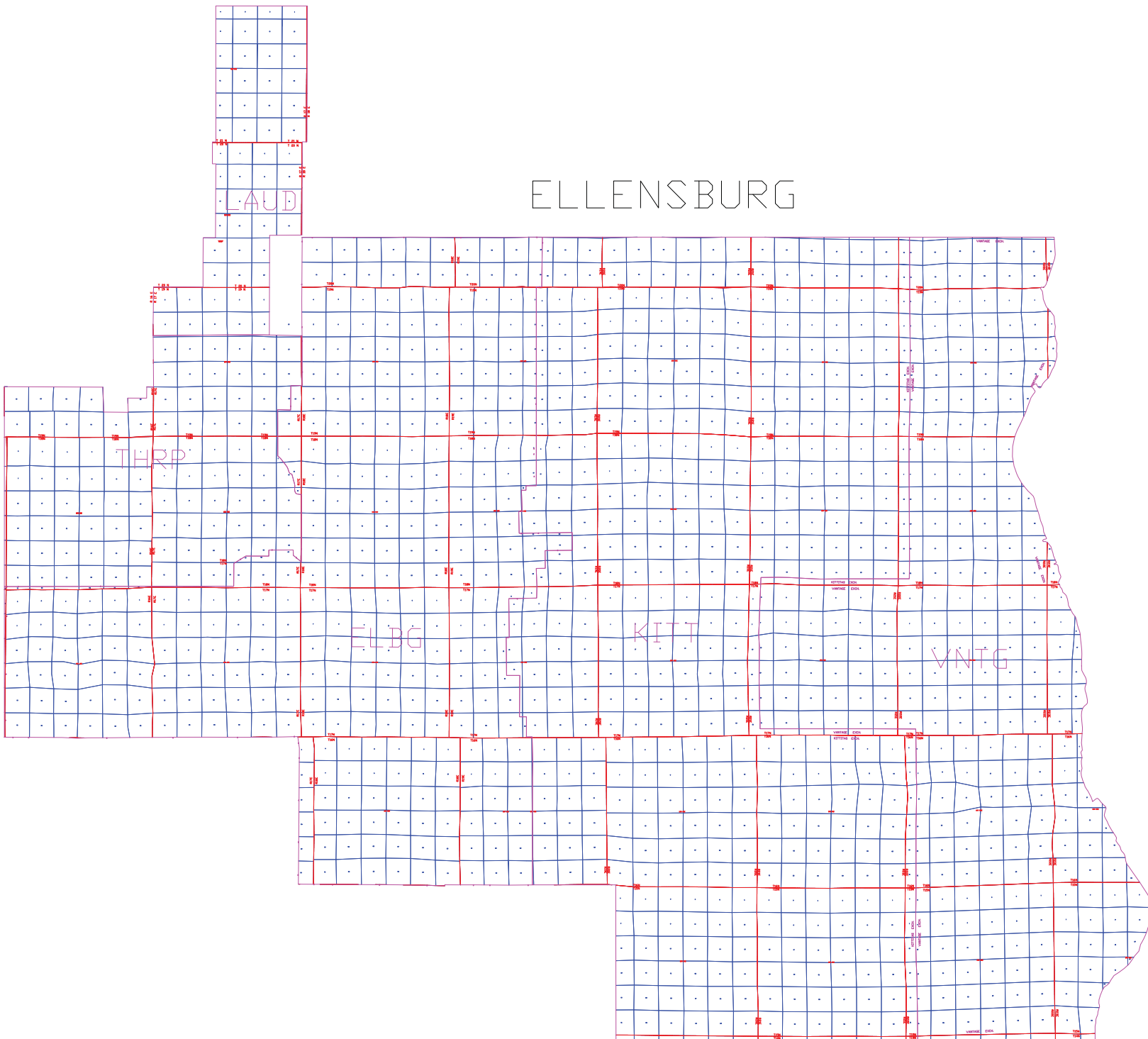
Exchange Area Boundary
