Megan Banks, under penalty of perjury under the laws of the State of Washington, declares as follows:

- I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection and Communications Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
- 2. I began an investigation into the activities of Dan's Professional Moving and Cleaning Service in August 2014, after receiving information from a customer.
- 3. On September 22, 2014, I conducted a search on www.yelp.com for "Dan's Professional Moving and Cleaning Service." The search produced a listing that included a telephone number, (206) 851-3886, and an email address, danspromovers@yahoo.com.¹
- 4. On September 22, 2014, I conducted a search of Washington Department of Revenue's Business Licensing Services for "Dan's Professional Moving and Cleaning Service." The search produced one record for Daniel Macio Saunders II d//b/a Dan's Professional Moving and Cleaning Service, governed by Daniel Macio Saunders II.²
- 5. I reviewed Commission records related to Daniel M. Saunders d/b/a Dan's Professional Moving and Cleaning Service to determine whether the company held a household goods permit. According to Commission records, as of January 29, 2015, there is no record of Daniel M. Saunders d/b/a Dan's Professional

Moving and Cleaning Service now (or ever) holding a household goods permit. A further review of commission records produced an investigation from November 2013. A previous investigator sent a compliance letter to Mr. Saunders on November 22, 2013. According to Commission records, Mr. Saunders received the compliance letter and was made aware of the requirement for a permit from the Commission.

- 6. On September 22, 2014, I sent an email to danspromovers@yahoo.com and requested a move within Seattle. On September 22, 2014, an unidentified person responded by email and stated that it would cost \$90 an hour for a three man crew and a truck. The response also stated that it would be \$80 an hour if I provided the truck.³
- 7. On January 14, 2015, I confirmed that no permit application had been submitted for "Daniel Saunders" or "Dan's Professional Moving and Cleaning Service." A search on www.yelp.com produced an active advertisement.⁴
- 8. On January 14, 2015, I emailed danspromovers@yahoo.com requesting an estimate for a move within Seattle. On January 14, 2015, a man who identified himself as "Dan" responded by email and stated that it would cost \$90 an hour for two men and a truck.⁵




