A copy of the referenced tariff sheets and a copy of this letter, both in .doc format, also accompany this letter.

The accompanying tariff revisions add to the Rules and Regulations section of the Tariff a new Rule and Regulation 18, entitled “Service Conditions,” which sets forth a requirement for the availability, presence and adequacy at the location to be served, of electric power necessary for certain of the Company’s services and connectivity thereto, sets forth responsibility of the subscriber to, or applicant for, the Company’s service with respect to such electric power and connectivity, sets forth a requirement for the availability to the Company of internal space at or near the served location, or at or near the location to be served, to accommodate installation of the Company’s equipment and facilities, and sets forth a requirement that the Company’s personnel have ready access to such space, equipment and facilities. Proposed Rule and Regulation 18 also provides that the Company may refuse to extend service, and may discontinue existing service, to any premises or location where the applicant or subscriber fails to satisfy its responsibility with respect to electric power and connectivity thereto, and conditions the Company’s obligations to install, maintain or restore service and/or to repair and/or replace its equipment or facilities upon the availability of such ready access.
