

### File online

1. Go online to **CorpRenewal.wa.gov** by **MAY 24, 2016**
2. Click "File online," then "Start renewal"
3. Enter your UBI number **603 505 043**
4. Next, enter your password **X77V 6224**

Our online application system will be down for maintenance May 25-June 7, 2016. Please file your annual report online by Tuesday, May 24, 2016.

Have your payment information handy. We accept E-check, MasterCard, Visa, Discover or American Express.

### **Avoid late fees – dissolution/termination**

To avoid a \$25 late fee, file online by Tuesday, May 24<sup>th</sup> or ensure that your paper annual report is received in our office by Tuesday, May 31<sup>st</sup>.

To renew by mail, call 1-800-451-7985 choose option 1 and then option 1 again to request a profit corporation or LLC license renewal and annual report form. Allow 10 business days to receive the form.
