Cascade Natural Gas Corporation ("Cascade" or "Company") filed Advice No. 17-12-01, docketed as UG-171160, on December 1, 2017. The Company herewith submits the following **replacement** sheets, stated to become effective February 1, 2018:

All other sheets **remain** as filed on December 1, 2017.

The purpose of this supplemental filing is to make the following correction, additions, and edits:

Sheet Nos. 6, 6-A, and 6-B of Rule 2, Definitions are revised such that the definitions of *applicant* and *customer* are identical to the definitions established in WAC 480-90-023. Also, definitions are added for *after hours* and *standard business hours*. The definitions are renumbered to accommodate the additions.

Sheet No. 7 of Rule 3, Establishing Service is revised to add a semi-colon at the end of (1)(b) under the section entitled, Requirements for Establishing Service.

Sheet Nos. 8 and 8-A of Rule 4, Customer Deposits and Other Security are revised to ensure the alternative deposit requirements for residential customers match WAC 480-90-113(5). A reference is added to Sheet 8-A stating that the customer who cannot pay a deposit may participate in the Winter Protection Plan as established in WAC 480-90-143, and language is added under Section (1)(d) and (1)(e) under Residential Deposit Criteria on Sheet No. 8 to clarify that a deposit is required unless a customer provides a reference from another utility stating the applicant has not received three or more delinquency notices in the prior twelve months and has not been disconnected for nonpayment.

Sheet No. 8-B of Rule 4, Customer Deposits and Other Security is revised to fix two typographical errors: 1) the missing word *interest* is added to the first sentence under the Section entitled, Returned Deposits; and 2) Repeated words are deleted under the Section entitled, Unclaimed Deposits.

Sheet No. 10 of Rule 6, Billings and Payments is revised to remove the section entitled, Priority of Payment.

Sheet No. 10-A, of Rule 6 Billings and Payments is revised to correct a typographical error.

Sheet No. 21 of Rule 17, Order of Priority for Gas Service is revised to include clarifying text that states the Company will curtail customers within the same order of priority in a manner that is appropriate for the situation. For instance, if the Company is curtailing Schedule 511 customers, it may be most efficient to curtail the largest Schedule 511 customers first. The Company may be able to resolve the constraint leading by curtailing only a portion of Schedule 570 customers, rather than all of them.

Sheet No. 22 of Rule 18, Limitation of Service to Applicants is revised to remove the phrase, "in its sole judgment".

Sheet Nos. 300 and 300.A from Schedule 300, Residential Conservation Incentive Program and Sheets 302 and 302.A from Schedule 302, Commercial/Industrial Conservation Program as filed in the subject filing on December 1, 2017, inadvertently listed old rebate amounts. These sheets are revised to incorporate the changes adopted in UG-170670.

Sheet Nos. 500-B and 500-C from Schedule 500, Municipal Taxes as filed in the subject filing on December 1, 2017, inadvertently included some old information that is herein updated. Specifically, the tax rates for West Richland are corrected and the Ordinance No. for Yakima is updated.
