The administrative rules at issue are WAC § 480-07-340, -355.

Boise manufactures and distributes paper products in the United States, including sheet papers, containerboard and corrugated containers, and market pulp. Boise is Pacific Power & Light Company's ("Pacific Power" or the "Company") largest customer in Washington, purchasing both power and power delivery services at its mill in Wallula, Washington.

Boise has a substantial interest in the outcome of Pacific Power's petition to use deferred accounting in connection with the Federal Tax Act signed into law on December 22, 2017. As Pacific Power's largest Washington customer, Boise could be substantially and directly affected by any deferral of costs related to the Federal Tax Act. Boise therefore requests leave to intervene in this Docket to represent its interests, which are directly affected by any change to Pacific Power's rates.
