To Whom It May Concern:

This letter is in response to the WUTC's Penalty Assessment TV-180198 on 3Z Movers LLC. I have reviewed the notice of penalties and would like to provide additional information.

Since the safety investigation and report of these findings, I have taken several steps to improve my operation of the company. I have completed a current medical examination and certification and there were no health conditions detected (see attached image). I have secured cargo insurance with National Indemnity (see attached image). I have also compiled a driver qualification file for myself including employment history, driving history, insurance history, driver's license copy, and the medical exam. Some of these documents I had on hand but not compiled in the correct filing manner. Similarly with the vehicle maintenance documentation, I had the documentation but it was not presented as a file to the investigator, I am working on re-organized the documentation into a proper maintenance record and will continue to maintain this file moving forward. I have my vehicle inspected and maintained regularly including brakes, oil, tires, lights, engine, transmission, etc. For the four violations of not having a background check for employees, Ali maintains his own moving company compliant with UTC regulations, Diarra Moving & Delivery. I am in progress with acquiring a background check for my ongoing move helper Ramde. Cody and Roy are no longer a concern.

With respect to the violations for not requiring a driver to make a record of duty status, I am not aware of the incidents that we did not meet the short haul exemptions and would like more information on this violation to ensure we are not uncompliant going forward.

I appreciate your consideration of the efforts I am making to turn these compliance issues around and maintain my status with the UTC.
