IMPORTANT NOTICE

Iliad Water Company LLC is filing with the Washington Utilities and Transportation Commission for a rate increase for the Lowper and Marbello water systems. If approved, the new rates will become effective on July 1, 2018. The reason for the increase is that the water supplier for each system has increased the rates for water provided. The supplier for Marbello is City of Monroe. The supplier for Lowper is Clallam County PUD. This is a pass through of the expense and is not something the company makes any money on.

The change in rates will, in theory, produce an estimated \$67,556.00 in additional revenue on the Marbello System and \$1,152.00 on the Lowper System. This represents 74.32 percent increase in the company's revenue on the Marbello System and 9.11 percent on the Lowper System.

There is no change to the base rate. The increase in your usage rates are shown per 100 cubic feet as follows:
