

## **Rate Increase Notice**

September 1, 2018

## Dear Valued Customer,

Waste Management is pleased to be your solid waste services collection provider. We value your business and welcome your feedback on our services.

Like all of us, the garbage industry is faced with many challenges today. Rising costs for processing yard waste and recyclables, labor and maintenance expenses have resulted in increased costs for us to provide collection services. Many of the above-mentioned costs have risen since our last general rate increase seven years ago in July 2011. Accordingly, we have applied for a change in rates, subject to the review and approval of the Washington Utilities and Transportation Commission (UTC). If approved, the new rates would become effective November 1, 2018.

The UTC has the authority to set final rates that may be lower or higher than the proposed rate reflected in this letter, depending on the outcome of its investigation. You can comment by using the "Submit a Comment" feature at the commission's web site, at <u>comments@utc.wa.gov</u> or by using the contact information below. Commission staff will make a recommendation to the commissioners at an open meeting in Olympia, which is scheduled for 9:30 a.m. on October 25, 2018. If you choose to do so, you will have an opportunity to comment in person at this meeting. The UTC is committed to providing reasonable accommodation to participants with disabilities.
