Puget Sound Energy (“PSE”) hereby submits, in connection with Docket UE-180954, the following substitute tariff sheet to replace Sheet No. 258-B submitted on November 15, 2018, under PSE’s Advice No. 2018-49. This substitute filing is pursuant to RCW 80.28.060 and Chapter 480-80 WAC and includes the following portion of PSE’s WN U-60 tariff for electric service:

**4<sup>th</sup> Revision of Sheet No. 258-B – Electricity Energy Efficiency Program – Large Power User Self-Directed Program (Continued)**

The purpose of this substitute filing is to correct a typographical error. Tariff Sheet 258-B Section 7 of the filing incorrectly lists the competitive phase as beginning on May 15, 2020. The correct beginning date is May 15, 2021.

The tariff sheet described herein reflects the original issue date of November 15, 2018, and effective date of January 1, 2019. Posting of the proposed tariff change, as required by WAC 480-100-193, is being made by posting the proposed tariff sheets on the PSE web site coincident with the date of this transmittal letter.
