## **IMPORTANT NOTICE**

As mandated by the Washington State Utilities and Transportation Commission Docket UW-161155 Order 2, Iliad Water Company, LLC has filed a General Rate Case Review. The review encompasses a one-year period from September 1, 2017 through August 31, 2018. The General Rate Case Review determines if the current customer rate structure is fair, just, reasonable, and sufficient.

The company's initial review has determined that it is necessary to increase rates. Commission staff has not yet performed its review. The reason for the increase is to reflect the actual costs of operation for the water systems. Historically, the revenues produced from existing rates have not covered the cost of operation and an authorized return on investment. In the past, operations have been at a loss and there have been some bills that have gone unpaid. This year the company has an operating loss of well over \$100,000 in expenses through August 31. As a result, a significant increase in rates is needed. This is not something the company takes lightly. However, the company cannot provide good service to you if it is constantly operating at a loss.

The change in rates will, in theory, produce an estimated \$293,258 in additional revenue. This represents 41.67 percent increase in the company's revenue.

The proposed rate change is as follows:

In addition, the Company is seeking increases to nonrecurring charges set out on the attached chart. These increases are estimated to generate approximately \$6,000.00 in annual revenue.

We have requested that the proposed rate increase become effective January 1, 2019, therefore the new rates would first be reflected on your February 9<sup>th</sup> billing statement.
