Dear Residential Customer,

This is to notify you of a proposed rate change for residential customers in the Eastside Disposal / Republic Services of Bellevue areas of King County. Should the Washington Utilities and Transportation Commission (Commission) approve our request customers will experience adjustments to all services provided by Eastside Disposal as outlined in the table below.

As you may know, it has been four years since our last general rate case. In that time Eastside Disposal has experienced increases in costs that are key to delivering our services; including labor, fuel and recycling processing costs. In addition, the company continues to invest in new assets to ensure it can deliver the safest, most efficient service possible. **If approved, the proposed rates will become effective September 1, 2019.**

The proposed rate increases for our residential services range from 0.29% to 7% and not all residential services are listed above. Most customers will likely experience increases of about 5% to 10%.

The commission has the authority to set final rates that may be either lower or higher from the company’s request, depending on the results of its investigation. Commission staff will make a recommendation to the commissioners at an open meeting in Olympia, which is scheduled on August 29, 2019.
