The Washington Utilities and Transportation Commission (Commission) is considering changes to the minimum and maximum rate bands contained in Tariff 15-C (Household Goods). Any changes to the rate bands will be determined following a review of industry expenses, market analysis, and comments provided by household goods companies or other interested parties. Stakeholders are strongly encouraged to submit written comments and attend the workshop.

**QUESTIONS FOR CONSIDERATION**

The Commission requests comments based on the questions provided below.

1. If the current maximum rates are not adequate, please identify those rates (e.g., long distance mileage rates, hourly rates, container prices, packing charges, etc.) and provide supporting financial data.
2. What percentage of moves are currently charged at the maximum rates?
3. Would rates based on location or region be appropriate? If so, please explain.

## WRITTEN COMMENTS

Written comments in response to the Notice must be filed with the Commission no later than 5 p.m., Friday, September 27, 2019, and must be submitted in electronic form, pursuant to WAC 480-07-250(3).
