RSI, thank you for forwarding on the certificate of liability. We will need a Form E within 60 days (once the permit is approved). The request for an exemption of the insurance rules to use surplus lines insurance will be considered at the October 10 open meeting. I will get back to you once the decision is made.

Mr. Diaz, we still need for you to obtain an active business license and tax account with the Washington Department of Revenue (DOR) and receive a UBI number. Business Licensing Services/DOR can be reached at 1-800-451-7985 or [www.bls.dor.wa.gov](http://www.bls.dor.wa.gov). If you are a corporation, you also need to register with the Secretary of State's office at 360-725-0377 or [www.sos.wa.gov](http://www.sos.wa.gov). Please note that since your company is based outside of Washington state, you will need to register as a "foreign entity" in Washington.
