Puget Sound Energy (“PSE”) submits in connection with Docket No. UG-200166 the following tariff sheet to replace the tariff sheet that accompanied PSE’s March 10, 2020 filing which was submitted under PSE’s Advice No. 2020-07. This filing includes the following portion of the Company’s WN U-2 tariff for natural gas service.

4th Revision of Sheet No. 21-C Rules and Regulations (Continued) Rule No. 9 Bills and Payment for Service (Continued)

The purpose of this substitute filing is to revise new language regarding the assessment of late payment fees. At Commission Staff’s suggestion, PSE is removing verbiage which states that late payment fees will be assessed at the Company’s sole discretion. To allow PSE to be immediately responsive to the rapidly changing economic conditions facing customers in the wake of the spreading COVID-19 virus, PSE respectfully requests that the Commission allow these tariff changes to become effective on March 13, 2020 with less than statutory notice (“LSN”). The information required by WAC 480-80-122 Tariff Changes with Less Than Statutory Notice, is contained in the LSN form which was filed on March 10, 2020.

The tariff sheet described herein reflects the original issue date of March 10, 2020, and effective date of April 10, 2020. Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-90-193.
