The purpose of this substitute filing is to revise new language regarding the assessment of late payment fees. At Commission Staff's suggestion, PSE is removing verbiage which states that late payment fees will be assessed at the Company's sole discretion. To allow PSE to be immediately responsive to the rapidly changing economic conditions facing customers in the wake of the spreading COVID-19 virus, PSE respectfully requests that the Commission allow these tariff changes to become effective on March 13, 2020 with less than statutory notice ("LSN"). The information required by WAC 480-80-122 Tariff Changes with Less Than Statutory Notice, is contained in the LSN form which was filed on March 10, 2020.
