**NOTICE CANCELLING BRIEF ADJUDICATIVE PROCEEDING**

RE: *In the Matter of the Investigation Washingtons Movers LLC for Compliance with WAC 480-15-560 and WAC 480-15-570, Docket TV-200636*

*In the Matter of the Penalty Assessment against Washingtons Movers LLC in the Amount of \$8,100 for violations of WAC 480-15, Docket TV-200635*

TO ALL PARTIES:

On July 9, 2020, regulatory staff (Staff) of the Washington Utilities and Transportation Commission (Commission) conducted a routine safety investigation of Washingtons Movers LLC (WM or Company) and documented 141 violations of Washington Administrative Code 480-15. Based on these violations, Staff proposed the Company receive an “unsatisfactory” safety rating.

On July 21, 2020, the Commission issued a Notice of Intent to Cancel Permit as a Household Goods Carrier (Notice) in Docket TV-200636 informing WM that the Commission will cancel the Company’s household goods permit effective September 8, 2020, unless the Company obtains Commission approval of a safety management plan prior to that date. The Notice required WM to file a proposed safety management plan by September 7, 2020, and set a brief adjudicative proceeding (BAP) for August 25, 2020.

Also on July 20, 2020, the Commission issued a Penalty Assessment against WM in Docket TV-200635 in the amount of \$8,100 for the violations discovered during Staff’s compliance review. On August 3, 2020, WM filed an application for mitigation of the penalty.

On August 18, 2020, Staff informed the presiding officer that the Company had submitted to Staff a proposed safety management plan. Staff evaluated the proposed plan and determined it is

acceptable. As such, Staff recommends the Commission cancel the BAP and enter an order addressing the Company's safety rating based on the evidence in the record.

Staff also explained that it confirmed that the Company waives its right to a hearing with respect to both dockets. Based on the parties' request to cancel the hearing, as well as Staff's approval of the Company's safety management plan, the Commission finds good cause to cancel the BAP set for August 25, 2020, at 9:30 a.m., and to enter an order based on the evidence in the record.

**THE COMMISSION GIVES NOTICE That the brief adjudicative proceeding in Docket TV-200636 set for August 25, 2020, at 9:30 a.m. is canceled.**
