DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declares as follows:

1. I am over 18 years of age, a citizen of the United States, a resident of the state of Washington, and competent to be a witness.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party and excursion service carriers that may be operating without the required Commission-issued certificate.
3. On March 23, 2018, the Commission received an application from Onstar Limousine LLC, d/b/a Seattle Transportation Group; Seattle City Limo, (Onstar Limousine or Company) to reinstate the Company's certificate to provide charter party and excursion carrier services in the state of Washington, which was assigned to Docket TE-180243. In the application, the Company provided UBI: 602-832-341; phone number (206) 788-6990; fax number (800) 217-5402; www.onstarlimo.com as its website address; tech@onstarlimo.com as its email address; P.O. Box 58461, Tukwila, WA 98138 as its mailing address; 3317 NE 11th Pl., Renton, WA 98056 as its physical address; listed Tekeste Tekle and Samson Tekle as the governing persons; and identified that the Company operated two motor vehicles: a 14-passenger 2007 Cadillac with license plate BHW6515 and a 14-passenger 2003 Hummer with license plate B94476N.¹
4. On October 26, 2020, the Commission canceled Onstar Limousine's charter party and excursion service carrier certificate for failing to submit acceptable proof of insurance in Docket TE-200884.² The cancellation letter directed Onstar Limousine to immediately cease

all operations associated with the certificate and informed the Company that advertising or operating without a valid certificate may lead to enforcement action.³

5. On June 8, 2021, I visited the Company's website, www.onstarlimo.com. Under the website's "Reservations" tab, I requested a quote for transportation for 19 passengers from Tacoma to Seattle on July 9, 2021, with the Company's 20-passenger Cadillac Escalade selected as the desired vehicle.⁴ After submitting the request, the website provided reference number 26236; phone number (206) 788-6990; email address reservations@seattle-trans.com; and the website stated, "Thank you for traveling with Neighborhood by Seattle Transportation Group."⁵
6. On June 10, 2021, I received an email from reservations@seattle-trans.com. The email identified Seattle Transportation Group as the carrier; included reference number 26236; provided phone number (800) 217-5402; quoted a total transportation cost of \$420; and directed me to the website of www.seattle-trans.com/book-a-ride to book transportation service with the Company.⁶
7. On June 10, 2021, I searched Commission records, which showed that Onstar Limousine did not have the required authority to provide charter party or excursion carrier service in the state of Washington.⁷
8. On June 10, 2021, I searched Washington Department of Revenue's (DOR) Business Licensing Service, which produced records showing that Onstar Limousine had an active limousine carrier endorsement through DOL, with one limousine vehicle in "On Hold" status.⁸ DOR's Business Licensing Service records also provided UBI: 602-832-341; P.O. Box 58461, Tukwila, WA 98138 as the mailing address; 3317 NE 11th Pl., Renton, WA 98056 as the location address; and listed Tekeste Tekle as the governing person.⁹
9. On June 11, 2021, I visited the Company's website, www.onstarlimo.com. On the Company's homepage, Onstar Limousine provided phone numbers (206) 788-6990 and (800) 217-5402; an email address of info@onstarlimo.com; an address of 16610 SE 128th St., Renton, WA 98059; and hourly rates for a "Lincoln stretch limo," "Hummer Super Stretch Limousine," "Mercedes Sprinter van," and an "Escalade Super Stretch ... [w]ith

room for 10 to 18 passengers.”¹⁰ On the Company’s “Reservations” form, I selected “Charter” as the service type; July 9, 2021, as the pick-up date; identified Tacoma as the pick-up location and Seattle as the drop-off location; selected 18 for the number of passengers; and clicked the button to select a vehicle, which provided a 20-passenger Cadillac Escalade and an 18-passenger Hummer H2 as the vehicle options to choose from.¹¹

10. On June 11, 2021, I visited the website referenced in the Company’s June 10 email, www.seattle-trans.com. On the Company’s homepage, Onstar Limousine provided phone numbers (206) 788-6990 and (800) 217-5402.¹² Under the website’s “Prom/ School Dance” tab, the Company provided hourly rates for an 8-passenger stretch limousine, 10-passenger stretch limousine, 14-passenger Mercedes Sprinter, 28-passenger Ford shuttle bus, 14-passenger Hummer H2, and 20-passenger Cadillac Escalade.¹³ On the Company’s “Book A Ride” form, I selected “Charter” as the service type; July 9, 2021, as the pick-up date; identified Tacoma as the pick-up location and Seattle as the drop-off location; selected 18 for the number of passengers; and clicked the button to select a vehicle, which provided a 20-passenger Cadillac Escalade and an 18-passenger Hummer H2 as the vehicle options.¹⁴
11. On June 11, 2021, I emailed Washington Department of Licensing (DOL) to inquire whether Onstar Limousine was actively licensed as a limousine carrier, and if so, which vehicles were actively registered as limousine vehicles.¹⁵ That same day, DOL responded stating that Onstar Limousine has an active limousine license and one vehicle registered as a limousine, a 2003 Hummer with license plate B94476N.¹⁶ The 2007 Cadillac Escalade, identified by the Company as a 20-passenger vehicle through its websites, was not registered as a limousine vehicle.
12. On June 11, 2021, I searched DOL’s DRIVES application for vehicle information on license plates BHW6515 and B94476N, which produced records showing that both the stretch Cadillac Escalade and stretch Hummer H2 were: (1) registered to Onstar Limousine; (2) registered to a mailing address of P.O. Box 58461, Tukwila, WA 98138; and (3) registered to a physical address of 3317 NE 11th Pl., Renton, WA 98056.¹⁷

13. On June 21, 2021, I called (800) 217-5402 and left a voicemail for Onstar Limousine. In the voicemail, I stated that I was looking to reserve transportation for an upcoming bachelor party and mentioned that I had received a quote of \$420 from the Company for the stretch Cadillac Escalade but wanted to discuss the transportation service in more detail.¹⁸
14. On June 21, 2021, I received a phone call from (206) 788-6990 and an automated message asked if I wanted to accept the call from “Onstar Limo Service.” After accepting the call, I spoke with an unidentified male subject (representative) who inquired what the itinerary was for my group and which date I was looking at for transportation service, to which I responded was roundtrip transportation from Tacoma to Seattle for a group of 16-19 people on July 9, 2021. After checking the Company’s calendar, the representative stated the Company already had a reservation booked for July 9, 2021, and that was the reason the Company never followed-up after providing the quote for the stretch Cadillac Escalade. The Company then divulged that for large groups its fleet consisted of a stretch Hummer H2, stretch Cadillac Escalade, and a minibus; however, the Company stated that it “is booked out two months.”
15. On July 21, 2021, I searched Commission records, which showed that Onstar Limousine did not have the required authority to provide charter party or excursion carrier service in the state of Washington.¹⁹
16. Based on paragraphs 3 through 15 above, Commission staff finds that Onstar Limousine operated as a charter party or excursion service carrier in the state of Washington after the cancellation of its certificate and without first obtaining the required certificate from the Commission.

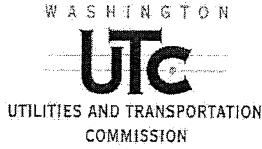

Dear Onstar Limousine LLC:


On Sept. 21, 2020, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation certificate would be canceled unless you submitted acceptable proof of insurance by October 23, 2020. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, **the Commission has CANCELED your certificate. You must immediately CEASE all operations associated with this certificate. If you advertise or operate without a valid certificate, the commission may take enforcement action against you.**

You have the right to a hearing. If you believe the Commission should not have canceled your certificate, you may ask the Commission to schedule a hearing before an administrative law judge. At the hearing the only issue the Commission will address is whether you had proof of insurance on file to avoid cancellation. Email your request to Mark L. Johnson, Secretary, at records@utc.wa.gov. You may also mail your request to WUTC, PO Box 47250, Olympia, WA 98504-7250. The Commission must receive your request within 14 days after the date of this letter.

You may apply to reinstate your certificate. Download the reinstatement application at www.utc.wa.gov. To locate application instructions, type "File Your Transportation Application Electronically" in the site search bar, and select this link. Then, click on the appropriate industry application.

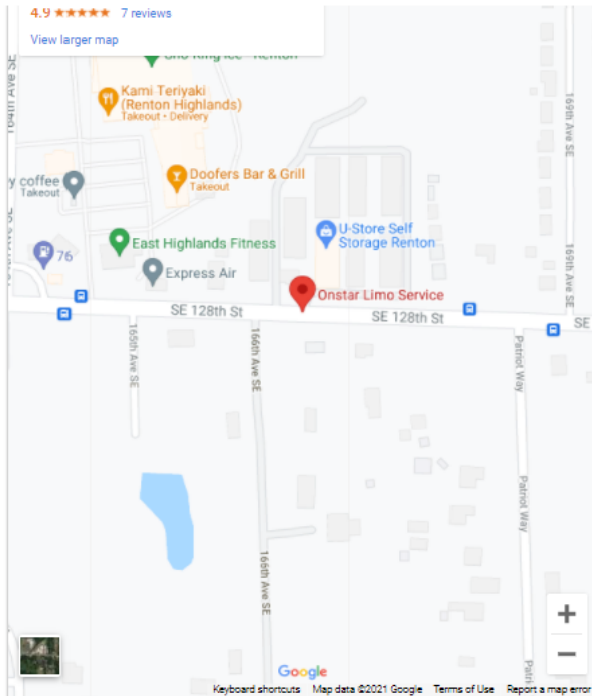

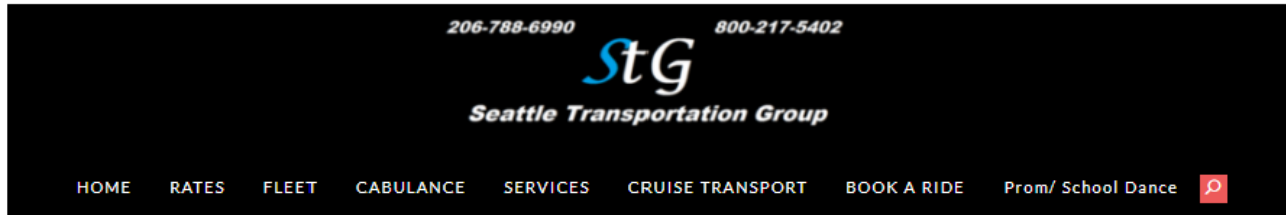

When I asked if I could reserve a vehicle other than the stretch Cadillac Escalade that I was quoted \$420 for, he again stated that the company is booked out a couple of months.

I then inquired about which vehicles the company has for future events and he stated they have a stretch Hummer H2, stretch Cadillac Escalade, and a mini bus. He stated that for a party of 19 he would recommend I reserve a bus instead a limousine, but again stated that he doesn't have availability on July 9th.

He then talked about how his company mostly does weddings now as opposed to parties with multiple stops and then referred me to Seattle 7 Days Limo, whom has an active cease and desist order from the commission. I asked if he knew of any companies from the Tacoma area to contact for last minute reservations and he responded that he didn't know of any since his company is out of Renton.

I thanked him for his time and the phone conversation was mutually terminated. Total conversation length: 6 minutes, 2 seconds.
