DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age, a citizen of the United States, a resident of the state of Washington, and competent to be a witness.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party or excursion service carriers that may be operating without the required Commission-issued certificate.
3. On January 27, 2021, I mailed a compliance letter to 1st Class Limousine, Inc., d/b/a 1st Class Charter Bus; 1st Class Freight; 1st Class Limousine & Airport Shuttle; Seattle Limousine and Transport, (1st Class Limousine or Company). The compliance letter stated Commission staff (Staff) believed 1st Class Limousine was operating as a charter party or excursion service carrier in the state of Washington without the required certificate and required the Company to respond in writing by February 12, 2021.¹
4. On January 30, 2021, 1st Class Limousine received the compliance letter at 12330 Roosevelt Way NE, Apt. 202, Seattle, Washington, 98125.² The Company never submitted a written response to Staff.
5. On February 23, 2021, I received a voicemail from Asteyayet Alemayohu of 1st Class Limousine. In the message, 1st Class Limousine stated it received the compliance letter and provided a phone number of (206) 444-5466 to discuss the matter.³

6. On March 8, 2021, I called (206) 444-5466 and spoke with Asteyayet Alemayohu of 1st Class Limousine. During the conversation, the Company stated that: (1) it was not operating, (2) it would apply for authority from the Commission when it began operating, and (3) it would not enter into an agreement to provide charter party or excursion carrier service without a Commission-issued certificate.⁴
7. On July 20, 2021, I searched Commission records, which showed that 1st Class Limousine did not have authority to provide charter party or excursion carrier service in the state of Washington.⁵
8. On July 20, 2021, I searched Washington Department of Revenue's (DOR) Business Licensing Service, which produced records showing that 1st Class Limousine's account was closed on June 30, 2019.⁶ DOR's Business Licensing Service records also provided UBI: 603-533-164; listed 701 NE Northlake Way, Seattle, Washington, 98105 as the location address; listed 12330 Roosevelt Way NE, Apt. 202, Seattle, Washington, 98125 as the mailing address; and listed Asteyayet Alemayohu as the governing person.⁷
9. On July 20, 2021, I searched Washington Secretary of State's (SOS) database, which produced records showing that 1st Class Limousine had an active account.⁸ SOS's records also provided UBI: 603-533-164; listed 12330 Roosevelt Way NE, Apt. 202, Seattle, WA 98125, as both the physical and mailing address; and listed Asteyayet Alemayohu as the governing person.⁹
10. On July 20, 2021, I visited the Company's website, www.1stclasslimousa.com. Under the website's "Reserve / Quote" tab, I submitted a "Transportation Service Quote Request" form seeking roundtrip transportation for 24 passengers from Woodinville to Seattle on December 5, 2021, with the Company's 30-passenger party bus selected as the desired vehicle.¹⁰
11. On July 22, 2021, I visited the Company's Facebook page and observed a post from April 12, 2021, where the Company posted a picture of a stretch Cadillac Escalade with the description, "We will also like to ask you to please share so all your friends and family can Enjoy the 1st Class Limousine service."¹¹

12. On July 22, 2021, I visited the “About” tab on the Company’s Facebook page, which provided the phone number of (206) 444-5466; an email address of info@1stclasslimousa.com; an address of 701 NE Northlake Way, Seattle, Washington, 98105; a website address of www.1stclasslimousa.com; and stated, “We provide the best Service with the Most Luxury Limousines, Charter Buses, Mini Co[a]ches, Vans, Town cars and Luxury SUV Escalade and our amazing Limo Buses.”¹²
13. On July 22, 2021, I visited the Company’s website, www.1stclasslimousa.com. On the homepage, the Company provided phone numbers (877) 328-5466 and (206) 444-5466; an email address of info@1stclasslimousa.com; and an address of 701 NE Northlake Way, Seattle, Washington 98105.¹³ Under the website’s “Fleet” tab, 1st Class Limousine advertised a “16-18 Passenger Cadillac Escalade,” “18-20 Passenger Hummer Limo,” “10 passenger Chrysler 300 Limo,” “18-20 Passenger Limo Bus,” “30 Passenger Party Bus,” “28 Passenger Charter Bus,” and “24 Passenger Infiniti SUV Limousine.”¹⁴ Under the website’s “Hourly Rates” tab, the Company listed the rates for its fleet and provided links to reserve each vehicle.¹⁵
14. On July 26, 2021, I called (206) 444-5466 and spoke with 1st Class Limousine. I explained that the Company never responded to my online quote request and that I was looking to reserve 1st Class Limousine’s 30-passenger bus on December 5, 2021, for a group of 24 people to be transported from Woodinville to Seattle and back for a company party.¹⁶ During the phone conversation, the Company was able to locate my online quote request from July 20, 2021; stated the 30-passenger bus was available for December 5, 2021; quoted an hourly rate of \$300 for the Company’s black bus; informed me that a deposit is required to book the transportation service; and stated the Company would send me an email with the pricing details.¹⁷
15. On July 29, 2021, I emailed info@1stclasslimousa.com and informed the Company that I never received an invoice after our phone conversation.¹⁸
16. On July 30, 2021, I received an email from info@1stclasslimousa.com. In the email, the Company quoted a price of \$3,850 for 10 hours and stated, “I can send the invoice for the

full rate or can send for 50% deposit and send the rest on December a few days before the service.”¹⁹

17. On January 25, 2022, I visited the Company’s website, www.1stclasslimousa.com. Under the website’s “Reserve / Quote” tab, I submitted a “Transportation Service Quote Request” form seeking roundtrip transportation for 20 passengers from Tacoma to Seattle on April 9, 2022.²⁰
18. On January 31, 2022, I called (877) 328-5466 and spoke with 1st Class Limousine. I explained the Company never responded to my online quote request and I was looking to reserve transportation from Tacoma to Seattle and back for 20 people on April 9, 2022. During the phone conversation, the Company offered a 24-passenger Infiniti stretch SUV for \$200 per hour and a black party bus for \$300-350 per hour that seats up to 30 passengers.²¹
19. On January 31, 2022, I called (206) 444-5466 and spoke with the same Company representative I had spoken to earlier. I explained that the prices on the Company’s website for the 24-passenger Infiniti stretch SUV and the 30-passenger party bus were different from the prices discussed over the phone. The Company stated that it needed to update its website to reflect the current prices.²²
20. On January 31, 2022, I searched Commission records, which showed that 1st Class Limousine did not have the required authority to provide charter party or excursion carrier service in the state of Washington.²³
21. Based on paragraphs 3 through 20 above, Commission staff finds that 1st Class Limousine operated as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.

RE: Charter and Excursion Service Carrier

Dear Asteyayet Alemayohu:

The Washington Utilities and Transportation Commission (commission) believes that 1st Class Limousine Inc., d/b/a 1st Class Charter Bus, 1st Class Limousine & Airport Shuttle, Seattle Limousine and Transport, et al (your company), is providing passenger transportation services that require charter and excursion authority from the commission. To advertise, solicit, offer, or enter into an agreement to provide charter and excursion services without a certificate is illegal and subject to a penalty of up to \$5,000 per violation.

The purpose of this letter is to learn more about your passenger transportation services, help you understand charter and excursion regulations, and direct your company to respond to avoid any potential penalties.

What you need to do

To avoid enforcement action by the commission, your company must:

- Immediately remove any advertisement offering charter and excursion services;
- Stop providing charter and excursion services; and
- Either submit a completed application (enclosed), file proof of insurance, and include the application fee; or respond in writing by February 12, 2021, explaining your company's operations and why they do not require operating authority from the commission.

Charter and excursion regulations

The commission regulates charter and excursion carriers in the state of Washington in the public interest.¹

A charter carrier means every person engaged in the transportation of persons for compensation over any public highway in this state who, pursuant to a common purpose and under a single contract, acquire the use of a motor vehicle to travel together as a group to a specified destination or for a particular itinerary, either agreed upon in advance or modified by the chartered group after leaving the place of origin.²

An excursion carrier means every person engaged in the transportation of persons for compensation over any public highway in this state from points of origin within any city, town, or area, to any other location within the state of Washington and returning to that origin. The service must not pick up or drop off passengers after leaving and before returning to the area of origin. The excursions may be regularly scheduled and compensation for the transportation offered or afforded must be computed, charged, or assessed on an individual fare basis.³

In relation to both charter and excursion carriers, a motor vehicle means every self-propelled vehicle with a manufacturer's seating capacity for eight or more passengers, including the driver, used on the public highways for the transportation of persons for compensation.⁴


In addition, a limousine endorsement through the Washington Department of Licensing allows a limousine carrier to operate an automobile with a seating capacity behind the driver of no more than 14 passengers.⁵

Application for charter and excursion authority

To provide charter and excursion service, your company must first apply for charter and excursion authority. Your company cannot operate as a charter and excursion carrier in the state of Washington until the commission grants you a certificate.



Alex stated he's going to apply for UTC authority in roughly two months for 14+ passengers and stated the only reason he hasn't already is that his company is not operating and has not operated since the pandemic hit.

Alex asked if he could keep the company's website up in meantime or if he needs to modify the website now and then put it back together once he receives authority, which Alex stated would be very costly. I explained that engaging as a charter/excursion carrier includes advertising, soliciting, offering, or entering into an agreement to provide charter/excursion service. I explained that I would allow Alex to keep the website up for a very short period of time due to the unique circumstances associated with the pandemic, but if the company does not seek UTC authority in the near future the company needs to remove the services and vehicles that are subject to UTC regulation.

I asked Alex hypothetically if he would provide charter/excursion service if his company received a request for service from a prospective customer and Alex stated he would not operate. I made it very clear that operating as a charter/excursion carrier without UTC authority would be a violation and subject to commission enforcement now that his company has been notified of the requirement for a certificate.

I then requested that Alex respond to the compliance letter in writing, and he stated he would respond via email. I explained that I want him to address every vehicle listed on his website and explain whether his company owns/operates each vehicle or if he refers business to another operator. I explained that if he refers business to another operator, to identify which company or companies own/operate said vehicles.

Alex stated that he would respond to me via email in the next couple of days. I encouraged Alex to reach out to me if he has any questions as to what his company can and cannot do. I thanked Alex for his time and the conversation was mutually terminated.
