DECLARATION OF MICHAEL DOTSON

NICHOLAS PAPADIMAS, D/B/A ORION NW

I, Michael Dotson, under penalty of perjury under the laws of the state of Washington, declare as follows:

- *I* I am over 18 years of age, a citizen of the United States, a resident of the state of Washington, and competent to be a witness.
- I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party and excursion service carriers that may be operating without the required Commission-issued certificate.
- On April 26, 2017, the Commission received an application from Nicholas Papadimas, d/b/a Orion NW, (Orion NW or Company) to reinstate the Company's certificate to provide charter party and excursion carrier services in the state of Washington, which was assigned to Docket TE-170296. In the application, the Company provided UBI: 604-045-629; phone number (206) 378-5888; www.orionnw.com as its website address; manager@orionnw.com as its email address; 3719 S 253rd PL, Kent, Washington, 98032, as its mailing and physical address; indicated that Nicholas Papadimas was the owner of the Company; and identified that the Company operated two motor vehicles: a 14-passenger 2007 Ford with license plate C72129D and a 26-passenger 2010 Ford with license plate C65350J.¹
- On October 8, 2020, Orion NW filed with the Commission its request to cancel certificate CH-64940, citing the economic downturn caused by the COVID-19 pandemic.² On October 9, the Commission issued a voluntary cancellation letter in Docket TE-200855, notifying Orion NW that its authority to provide charter party and excursion service was canceled and that the Company "must cease all operations associated with this certificate."³

- 5 On August 4, 2021, I searched Commission records, which produced records showing that Orion NW is not a certificated charter party or excursion service carrier in the state of Washington.⁴
- 6 On August 4, 2021, I searched Washington Department of Revenue's (DOR) Business Licensing Service for UBI: 604-045-629, which produced records showing that Orion NW has an active business license. The record showed Nicholas Papadimas as the governing person with an address of 3719 S 253rd PL, Kent, Washington, 98032.⁵
- 7 On August 4, 2021, I searched Washington Department of Licensing's DRIVES application for information on a bus featured on the Company's website.⁶ The records showed that the 26-passenger Ford bus with license plate C65350J was registered to Nicholas Papadimas d/b/a OrionNW.⁷
- 8 On August 4, 2021, I visited the Company's website, <u>www.orionnw.com</u>. Under the website's "Contact Us" tab, I requested a quote for transportation for 20 passengers from Olympia to Seattle and back on August 15, 2021.⁸ After submitting the request, the website stated, "Thank you for your inquiry!, We will get back to you within 48 hours."⁹
- 9 On August 8, 2021, I received an email from <u>manager@orionnw.com</u>. The email quoted a total transportation cost of \$1,000.¹⁰
- 10 On August 12, 2021, I sent a follow-up email requesting the same trip for the date of August 26, 2021.¹⁰
- 11 On August 13, 2021, I sent a clarification follow-up email confirming that the Company was available on August 26, 2021. The Company confirmed that it was available on that date.¹⁰




