Renewable Energy Senior Program Manager Pacific Power The proposed tariff revisions would modify Schedule 70 and Schedule 73 to revise the definition of one block of renewable energy from 200 kilowatt-hours (kWh) to 100 kWh, effective January 1, 2022.

Background

Pacific Power launched its Blue Sky program in 2000 to allow customers the option to purchase renewable energy credits (RECs) to offset some or all their usage from renewable energy sources while also supporting renewable energy development. Funds collected through the Blue Sky Schedules are used to acquire RECs and cover program expenses. Any remaining funds are then used to help support new community-based renewable energy projects. Since its inception, Blue Sky customers across PacifiCorp's service area have purchased more than 10 billion kWh of renewable energy and supported more than 300 community-based renewable projects. In addition to the support from customers, the Blue Sky program has been recognized by the National Renewable Energy Laboratory on its Top 10 Utility Green Power Pricing Programs list for 19 years. Since 2020, Blue Sky customers have paid \$1.95 for each 200 kWh block.

Filing Overview

The price of RECs from 2012-2019 was stable. This helped inform the Company's decision to file an advice filing on October 21, 2019, requesting approval to increase the size of each Blue Sky block from 100 kWh to 200 kWh of renewable energy while maintaining the current price of \$1.95 per block. This was an effort to meet growing customer demands in the renewable energy sector and to better align with market conditions for REC prices. Since 2020, however, the price of RECs has increased to a point where it is unsustainable for the program to maintain the size of each block at 200 kWh. Accordingly, the Company requests to reduce the size of each block back to 100 kWh to reflect the market fluctuation.

How will I be billed for my Blue Sky purchase?	Your Blue Sky Block charge will be listed as a separate line item on your monthly Pacific Power electricity bill. This charge is in addition to your regular electricity bill.
How will the Blue Sky charge on my bill be calculated?	\$1.95 per 200-kwh block of Blue Sky through 2021. Starting January 2022, the block size will change to 100 kWh and the charge will be calculated as \$1.95 per 100-kWh block.
Will the Blue Sky rate change over time?	Blue Sky rates are based on current Commission approved tariffs. Pricing is subject to change. All rate changes require approval from the Commission. Customers will be notifed of any price change in advance through customer communication.
What is the required contract length?	The contract is month-to-month.
Can I cancel my participation?	You may cancel your participation at anytime with no fee by calling I-800-769-3717 or writing to Pacific Power, P.O. Box 400, Portland, Oregon 97207-0400. There is no minimum contract length.
What other fees might I be charged?	You must also pay all applicable federal, state or local taxes.
