RATE INCREASE NOTICE FOR RESIDENTIAL GARBAGE, RECYCLING AND YARD WASTE

Dear Customer:

Harold LeMay Enterprises, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC and became effective October 1, 2022. Since that time, the Company discovered an error in the final approved and published tariff rates. This increase request is to correct that error to ensure the rates the Company bills to customers are reflective of the revenue requirement previously approved by the WUTC. See below for the impact of the error correction on current rates.

If approved by the WUTC, the proposed rates below will become effective January 1, 2023.
