Dear Ms. Maxwell:

Puget Sound Energy (“PSE”) hereby submits in connection with Docket UG-220887 a revised tariff sheet to replace the tariff sheet that accompanied PSE’s November 30, 2022 filing submitted under PSE’s Advice No. 2022-24. This substitute sheet filing includes the following portion of PSE’s WN U-2 Tariff for natural gas service.

29th Revision Sheet No. 101B Schedule 1 Tax Adjustment (Continued)

The purpose of this substitute sheet filing is to update the ordinance number for the new City of Puyallup (“City”) utility tax rate that will become effective on January 1, 2023. PSE filed the tariff change with the Washington Utilities and Transportation Commission on November 30, 2022, under Advice No. 2022-24 after the City passed the new utility tax rate of 3.2% on November 22, 2022. No new ordinance number was assigned at the time of the passage. On December 6, 2022, City of Puyallup notified PSE that the ordinance for the new utility tax rate is Ordinance No. 3262. Attachment A to this filing is a copy of Ordinance No. 3262 in its draft form that the City of Puyallup sent to PSE on December 6, 2022.

The tariff sheet described herein reflect an issue date of November 30, 2022, and an effective dates of January 1, 2023. Posting of the proposed tariff change for public inspection and review, as required by law and the Commission’s rules and regulations, is being completed in accordance with WAC 480-90-193(1). Pursuant to WAC 480-90-195, notice to customers will be provided in the first billing after the tariff revisions become effective. The approximately 11,000 PSE natural gas service customers within the City of Puyallup will receive notification in the form of a bill message.
