DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age and competent to testify to the facts contained herein.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party or excursion service carriers that may be operating without the required Commission-issued certificate.
3. On March 11, 2019, the Commission received the application for Crescent Bar Eventours, LLC, d/b/a CB Eventours, LLC; Crescent Bar Charters LLC (Crescent Bar Eventours or Company), to provide charter and excursion carrier services in the state of Washington. In the application, Crescent Bar Eventours provided the phone number (509) 289-7418; listed UBI: 604-406-225; provided the email address of cbeventours@gmail.com; listed the mailing address of 23706 48th Ave. W, Mountlake Terrace, Washington, 98043; listed the physical address of 8818 Crescent Bar Rd. NW, Unit 180, Quincy, Washington, 98848; listed Maria McRae as the owner of Crescent Bar Eventours; and provided its two motor vehicles: (1) a 15-passenger 2008 Ford Econoline with license plate number AUY4808 and vehicle identification number 1FD4E45S18DA98539, and (2) a 34-passenger 1986 International S-Series with license plate number C83412K and vehicle identification number 1HVLNHGL5GHA13557.<sup>1</sup>
4. On May 1, 2019, the Commission granted Crescent Bar Eventours authority for charter and excursion carrier services in Docket TE-190168.<sup>2</sup>
5. On December 16, 2019, the Commission notified Crescent Bar Eventours that its certificate would be canceled if the Company failed to submit acceptable proof of insurance by January

24, 2020. On January 29, 2020, the Commission issued a cancellation letter to Crescent Bar Eventours in Docket TE-200057 for failing to submit acceptable proof of insurance, which notified the Company that its authority to provide charter party or excursion carrier service was canceled and that the Company “must immediately cease all operations associated with this certificate.”<sup>3</sup> In addition, the letter informed Crescent Bar Eventours that “If you advertise or operate without a valid certificate, the commission may take enforcement action against you.”<sup>4</sup> The cancellation letter was served by mail to Crescent Bar Eventours at 23706 48th Ave. W, Mountlake Terrace, Washington, 98043, as well as served electronically to Crescent Bar Eventours at cbeventours@gmail.com.<sup>5</sup>

6. On October 10, 2022, I searched Commission records, which showed that Crescent Bar Eventours did not have the required authority to provide charter party or excursion carrier service in the state of Washington.<sup>6</sup>
7. On October 10, 2022, I contacted Crescent Bar Eventours through its Facebook page, [www.facebook.com/cbeventours](http://www.facebook.com/cbeventours), and asked if the Company is still providing service with its limo bus. That same morning, Crescent Bar Eventours responded “Yes we do.”<sup>7</sup>
8. On December 6, 2022, I responded to the Company’s message through Facebook Messenger and inquired what the cost would be for bus transportation service on January 14, 2023, for 15-16 people from Crescent Bar, Washington, to various bars and then a Wenatchee Wild hockey match in Wenatchee, Washington, and then returned to Crescent Bar, Washington. That evening, Crescent Bar Eventours responded with a quote of “roughly \$1,800 for the 9 hours.”<sup>8</sup>
9. On December 19, 2022, I received an email from Crescent Bar Eventours confirming the transportation service scheduled for January 14, 2023.<sup>9</sup> The email was sent from Maria McRae at [cbeventours@gmail.com](mailto:cbeventours@gmail.com), provided the phone number (509) 289-7418, and referenced that the “invoice has been sent via Square.”<sup>10</sup>

10. On December 19, 2022, I received an invoice from Crescent Bar Eventours in the amount of \$2,068.20.<sup>11</sup>
11. On December 19, 2022, I searched Washington Department of Revenue's (DOR) Business Licensing Service, which produced records showing Crescent Bar Eventours in active status in the state of Washington. DOR's records provided UBI: 604-406-225; listed a location address of 8818 Crescent Bar Rd. NW, Unit 180, Quincy, Washington, 98848; listed a mailing address of 23706 48th Ave. W, Mountlake Terrace, Washington, 98043; and identified Maria McRae as the governing person.<sup>12</sup>
12. On December 19, 2022, I searched Washington Secretary of State's (SOS) Corporations and Charities Filing System, which produced records showing Crescent Bar Eventours in active business status in the state of Washington. SOS's records provided UBI: 604-406-225; listed a street address of 8818 Crescent Bar Rd. NW, Unit 180, Quincy, Washington, 98848; listed a mailing address of 23706 48th Ave. W, Mountlake Terrace, Washington, 98043; listed Maria McRae as the registered agent with the same street and mailing addresses; and identified Maria McRae as the governing person.<sup>13</sup>
13. On December 19, 2022, I visited the Company's website, [www.cbeventours.com](http://www.cbeventours.com), which provided the phone number (509) 289-7418; provided a link to the email address of [cbeventours@gmail.com](mailto:cbeventours@gmail.com); provided a link to the Company's Facebook page, [www.facebook.com/cbeventours](http://www.facebook.com/cbeventours); and provided a link to the Company's Instagram page, [cbeventours](https://www.instagram.com/cbeventours).<sup>14</sup> The website's homepage advertised transportation service with its limo bus for concerts, wineries, birthday parties, anniversaries, high school dances, proms, casino trips, and shopping expeditions; and provided a picture of a black Ford Econoline shuttle bus.<sup>15</sup>
14. On the website's "Gorge Shuttles" page, Crescent Bar Eventours advertised roundtrip transportation service to the Gorge Amphitheater for \$75 per person using its 14-passenger limo bus and \$70 per person using its 34-passenger Jolly Trolley bus.<sup>16</sup> The "Gorge Shuttles" page also provided a 2023 Gorge Amphitheater concert lineup, which demonstrated that the Company is actively maintaining its website.

15. On the website's "Event Shuttles" page, the Company advertised roundtrip transportation service to Oktoberfest using its limo bus for \$85 per person and provided a picture of a black Ford Econoline shuttle bus.<sup>17</sup>
16. On the website's "Vineyard Shuttles" page, Crescent Bar Eventours advertised roundtrip wine tour transportation service for "up to 15 people" with its limo bus and "up to 34 people" with its Jolly Trolley bus, directed prospective customers to "contact Maria at 509-289-7418 for pricing," and provided pictures of a group inside and outside of a black Ford Econoline shuttle bus.<sup>18</sup>
17. On the website's "Private Parties" page, the Company advertised various group transportation services for "up to 15 people" with its limo bus and "up to 34 people" with its Jolly Trolley bus, directed prospective customers to "contact Maria at 509-289-7418 for pricing," and provided a picture of a group riding inside a bus.<sup>19</sup>
18. On the website's "Contact Us" page, Crescent Bar Eventours identified that it is located in Crescent Bar, Washington; stated that it "has concert shuttles to the Gorge Amphitheater, vineyard shuttles throughout the Central Washington area, and private party shuttles;" directed prospective customers to call (509) 289-7418 for reservations or shuttle information; provided a link to its email address of cbeventours@gmail.com for questions; provided United States Department of Transportation (USDOT) Number 3255908; and provided UBI: 604-406-225.<sup>20</sup> Crescent Bar Eventours did not have interstate authority through USDOT to federally preempt the Company from the Commission's regulation.<sup>21</sup>
19. On December 19, 2022, I visited Crescent Bar Eventours' Facebook page, [www.facebook.com/cbeventours](http://www.facebook.com/cbeventours), which provided the address 8818 Crescent Bar Rd. NW, Quincy, Washington, 98848; provided phone number (509) 289-7418; listed the email address of cbeventours@gmail.com; provided the website address [www.cbeventours.com](http://www.cbeventours.com); and identified its Instagram page as cbeventours.<sup>22</sup>
20. On December 19, 2022, I visited the Company's Instagram page, cbeventours, which shares many of the same photos provided on Crescent Bar Eventours' Facebook page.<sup>23</sup>

21. On December 19, 2022, I searched Commission records, which showed that Crescent Bar Eventours did not have the required authority to provide charter party or excursion carrier service in the state of Washington.<sup>24</sup>
22. On December 21, 2022, I searched Washington Department of Licensing's (DOL) DRIVES application for vehicle information on the two motor vehicles identified by the Company in its 2019 application. DOL's records showed the 34-passenger 1986 International S-Series with license plate number C83412K and vehicle identification number 1HVLNHGL5GHA13557 is registered to Crescent Bar Charters LLC at the physical and mailing address of 8818 Crescent Bar Rd. NW, Unit 180, Quincy, Washington, 98848; and the 15-passenger 2008 Ford Econoline with license plate number AUY4808 and vehicle identification number 1FD4E45S18DA98539 is registered to Crescent Bar Charters LLC at the physical and mailing address of 9119 Seahawk Ln. NW, Quincy, Washington, 98848.<sup>25</sup>
23. Based on paragraphs 3 through 22 above, Commission staff finds that Crescent Bar Eventours is operating as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.

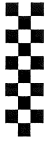

Dear Crescent Bar Eventours, LLC:

On December 16, 2019, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation certificate would be canceled unless you submitted acceptable proof of insurance by January 24, 2020. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, **the Commission has CANCELED your certificate. You must immediately CEASE all operations associated with this certificate. If you advertise or operate without a valid certificate, the commission may take enforcement action against you.**

**You have the right to a hearing.** If you believe the Commission should not have canceled your certificate, you may ask the Commission to schedule a hearing before an administrative law judge. At the hearing the only issue the Commission will address is whether you had proof of insurance on file to avoid cancellation. Email your request to Mark L. 


