Due to increases in wages, transportation, and other operating costs, we have filed with the Washington Utilities and Transportation Commission (UTC) for a 5.54% overall rate increase. Our last general operating increase occurred in 2019. If approved, the proposed rates below would become effective February 1, 2023.
