# NOTICE OF PENALTIES INCURRED AND DUE FOR VIOLATIONS OF LAWS AND RULES

### PENALTY ASSESSMENT: TG-230504 PENALTY AMOUNT: \$100

Sanitary Service Company, Inc. P.O. Box 1702 Bellingham, WA 98227

The Washington Utilities and Transportation Commission (Commission) believes Sanitary Service Company, Inc., (SSC or Company) violated Washington Administrative Code (WAC) 480-70-201, Vehicle and Driver Safety Requirements, which adopts Title 49 Code of Federal Regulations (49 C.F.R.) Part 393 – Parts and Accessories Necessary for Safe Operation.

Revised Code of Washington (RCW) 81.04.405 allows penalties of \$100 for each violation. In the case of an ongoing violation, every day's continuance is considered a separate and distinct violation.

On June 21, 2023, Commission Motor Carrier Investigator Sandra Yeomans completed a routine safety investigation of SSC and documented the following violation:

• One violation of 49 C.F.R. § 393.51 – No or defective brake warning device or pressure gauge. Commission staff (Staff) discovered a commercial motor vehicle (CMV) with a defective brake warning device. This CMV was placed out-of-service.<sup>1</sup>

The Commission considered the following factors in determining the appropriate penalties for this violation:

- 1. How serious or harmful the violation is to the public. The violation noted is serious and potentially harmful to the public. Solid waste collection companies operating CMVs with defective brake warning devices put the traveling public at risk. This violation presents a safety concern.
- 2. Whether the violation was intentional. Considerations include:
  - Whether the Company ignored Staff's previous technical assistance; and
  - Whether there is clear evidence through documentation or other means that shows the Company knew of and failed to correct the violation.

SSC began its operations in 1929 and has been subject to numerous safety investigations conducted by Staff. The Company knew or should have known about this requirement,

however, there is no evidence to suggest SSC ignored Staff's previous technical assistance.

- 3. Whether the Company self-reported the violation. SSC did not self-report this violation.
- 4. Whether the Company was cooperative and responsive. The Company was cooperative throughout the safety investigation and made corrections as violations were discovered.
- 5. Whether the Company promptly corrected the violation and remedied the impacts. The Company corrected the violation of 49 C.F.R. § 393.51.
- 6. **The number of violations.** Staff identified 14 violation types with a total of 51 individual occurrences during the routine safety investigation of SSC. Of those violations, Staff identified one violation type with one occurrence that warrants a penalty in accordance with the Commission's Enforcement Policy.
- 7. **The number of customers affected.** SSC reported traveling 1,494,241 miles in 2022. This violation presented a public safety risk.
- 8. The likelihood of recurrence. Staff provided technical assistance with specific remedies to help the Company assess how well its safety management controls support safe operations and how to begin improving its safety performance. SSC was cooperative throughout the safety investigation and made corrections to come into compliance. Considering these factors, Staff believes the likelihood of recurrence is low.
- The Company's past performance regarding compliance, violations, and penalties. On September 29, 2014, the Commission assessed a \$100 penalty against SSC in Docket TG-143565 for safety violations of WAC 480-70-201. The Company paid the penalty in full.
- 10. **The Company's existing compliance program.** Rodd Pemble, Safety Director of SSC, is responsible for the Company's safety compliance program.
- 11. The size of the Company. SSC employs 41 drivers and operates 63 CMVs. The Company reported \$45,179,006 in gross revenue in 2022.

The Commission's Enforcement Policy provides that some Commission requirements are so fundamental to safe operations that the Commission will issue mandatory penalties for each occurrence of a first-time violation.<sup>2</sup> The Commission generally will assess penalties by violation category, rather than per occurrence, for first-time violations of those critical regulations that do not meet the requirements for mandatory penalties. The Commission will assess penalties for any

equipment violation meeting the Federal Motor Carrier Safety Administration's "out-of-service" criteria and for repeat violations of critical regulations, including each occurrence of a repeat violation.

The Commission has considered these factors and determined that it should penalize SSC \$100 (Penalty Assessment), calculated as follows:

• One violation of 49 C.F.R. § 393.51 – No or defective brake warning device or pressure gauge. The Commission assesses a penalty of \$100 for this out-of-service violation.

This information, if proven at a hearing and not rebutted or explained, is sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Alternatively, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

You must act within 15 days after receiving this notice to do one of the following:

- Pay the amount due.
- Contest the occurrence of the violation.
- Admit the violation but request mitigation of the penalty amount.

Please indicate your selection on the enclosed form and submit it electronically through the Commission's web portal at <u>https://efiling.utc.wa.gov/Form</u> within FIFTEEN (15) days after you receive this Penalty Assessment.<sup>3</sup> If you are unable to use the web portal, you may submit it via email to records@utc.wa.gov. If you are unable to submit the form electronically, you may send a paper copy to the Washington Utilities and Transportation Commission, PO Box 47250, Olympia, Washington 98504-7250.
