On September 15, 2023, Cascade Natural Gas (“Cascade” or “Company”) submitted five advice filings (WA23-09-01, WA23-09-02, WA23-09-03, WA23-09-04, and WA23-09-05); each with the requested effective date of November 1, 2023. The filings seek to revise customer rates due to the Purchased Gas Adjustment and other non-gas cost adjustments. A description of the cost adjustment by advice number and docket is listed below:

The proposed rate changes will affect all of Cascade’s Washington customers. Cascade serves approximately 202,519 residential, 27,445 commercial, 492 industrial, 100 large volume, and seven industrial interruptible customers in the state of Washington.

In accordance with WAC 480-90-194(3), the Company provided its customers notice of the subject filings in the following ways:

- 1) Bill inserts notifying customers of this proposed bill changes were sent to customers starting with bills issued on September 15, 2023. [per WAC 480-90-194(3)(a)]
