**\* Present provisions are:**  
Under RCW 81.28.050, 45 days are required for customer notice of any tariff changes.

**\* Proposed changes are:**  
We are requesting to follow WAC 480-70-271 (2)(a) which would allow for notification on the customer's first invoice after approval and align with our bill cycle.

**\* Explain why the company is proposing this tariff revision:**  
We are requesting this change as it lowers cost to the rate payer by notifying them along with their invoice. This would also best align with our bill cycle and minimize customer confusion. Additionally, we hoped to identify the customers impacted before submitting the filing but needed additional resources to identify customers that we service within this area.

**\* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**  
We are requesting to allow customers to be noticed on the first bill as previously allowed and as stated in WAC 480-70-271 (2)(a). This would best align with our billing cycle and minimize customer confusion and cost with additional notices.
