DECLARATION OF JACOB BRUNTON

I, Jacob Brunton, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age and competent to testify to the facts contained herein.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party or excursion service carriers that may be operating without the required Commission-issued certificate.
3. On January 24, 2019, the Commission received the application for Chelan Wine Tours and Excursions LLC (Chelan Wine Tours or Company) to provide charter and excursion carrier services in the state of Washington. In the application, Chelan Wine Tours provided the phone number (509) 630-6193; listed UBI: 604-355-782; provided the email address of chelanbus4fun@gmail.com; listed the mailing and physical address of 204 N Navarre St, Chelan, Washington, 98816; listed Lee Reynolds, Malissa Reynolds, Tyanna Hankins, and Kenney Pribble as the owners of Chelan Wine Tours; and provided its one motor vehicle: (1) a 15-passenger 1996 Ford Econoline with license plate number BME2940 and vehicle identification number 1FDKE30G1THA90205.¹
4. On April 3, 2019, the Commission granted Crescent Bar Eventours authority for charter and excursion carrier services in Docket TE-190046.²
5. On April 6, 2022, Chelan Wine Tours requested that the Commission cancel its certificate because Chelan Wine Tours is no longer operating. On April 6, 2022, the Commission issued a cancellation letter to Chelan Wine Tours in Docket TE-220251, which notified the Company that its authority to provide charter party or excursion carrier service was canceled and that the Company “must immediately cease all operations associated with this

certificate.”³ The cancellation letter was served electronically to Chelan Wine Tours at chelanbus4fun@gmail.com.⁴

6. I was assigned a routine check for compliance to investigate Chelan Wine Tours due to the voluntary cancellation of authority for charter and excursion carrier services.
7. On December 5, 2023, I searched Commission records, which showed that Chelan Wine Tours did not have the required authority to provide charter party or excursion carrier service in the state of Washington.⁵
8. On December 5, 2023, I searched Washington Department of Revenue’s (DOR) Business Licensing Service, which produced records showing Chelan Wine Tours in active status in the state of Washington. DOR’s records provided UBI: 604-355-782; listed a location address of 188 Chelan Ave, Chelan Falls, Washington, 98817; listed a mailing address of PO Box 832, Chelan, Washington, 98816; and identified Cristian Montalovo, Isaac Montalovo, and Madison Reynolds as the governing people.⁶
9. On December 5, 2023, I searched the Washington Secretary of State’s (SOS) Corporations and Charities Filing System, which produced records showing Chelan Wine Tours in active business status in the state of Washington. SOS’s records provided UBI: 604-355-782; listed a street address of 188 Chelan St, Chelan Falls, Washington, 98817; listed a mailing address of PO Box 823, Chelan, Washington, 98816; listed Madison Reynolds as the registered agent with the same street and mailing addresses; and identified Cristian Montalovo, Isaac Montalovo, and Madison Reynolds as the governing people.⁷
10. On December 5, 2023, I visited the Company’s website, www.chelanwinetoursandexcursions.com, which provided the phone number (509) 655-6187 and provided the email address of chelanwinetoursandexcursions.com.⁸ The website’s homepage advertised transportation service with its limo for Chelan area wineries and provided a picture of a white Ford Excursion limo.⁹
11. On the website’s “Transportation Excursion Tours” page, Chelan Wine Tours advertised wine tour and wedding excursion transportation service for \$180 for a 6 person minimum and \$30 per additional person using its 14-passenger limo bus and \$75 extra for out of

service areas.¹⁰ The “Transportation Excursion Tours” page also provided a book now link, which demonstrated that the Company is actively maintaining its website.

12. On the website’s “Calendar” page, the Company displayed booked transportation services for the year of 2024, which demonstrated that the Company is actively conducting business.¹¹
13. On the website’s “Tours” page, Chelan Wine Tours advertised roundtrip wine tour transportation service for “14 or less” with its limo at \$70 per person with a minimum 6 person \$420 charge. The website provided a link to book now.¹²
14. On the website’s “Booking” page, the Company advertised various group transportation services for “Max 14” people with its limo, which allowed customers to book and pay online.¹³
15. On the website’s “Contact Us” page, Chelan Wine Tours identified that it is located in Chelan, Washington; stated that it “proudly serves the Chelan Valley”; provided (509) 655-6187 for phone contact information; provided its email address of chelanbus4fun@gmail.com; and stated “Open March thru Mid-November.”¹⁴ Chelan Wine Tours did not have interstate authority through USDOT to federally preempt the Company from the Commission’s regulation.¹⁵
16. On December 5, 2023, I visited the Company’s Instagram page, chelanwinetours, where I observed photos of wine tours being provided.
17. On December 5, 2023, I searched Washington Department of Licensing’s (DOL) DRIVES application for vehicle information on the motor vehicles identified by the Company in its 2019 application. DOL’s records showed the 15-passenger 2008 Ford Econoline with license plate number BME2940 and vehicle identification number 1FDKE30G1THA90205 is registered to Chelan Wine Tours and Excursions at the physical and mailing address of 204 N Navarre St, Chelan, Washington, 98816.¹⁶
18. On January 4, 2024, under an assumed name, I contacted Chelan Wine Tours via the website email chelanbus4fun@gmail.com and asked if the Company is still providing wine tour services. On January 5, 2024, I received an email from Chelan Wine Tours with the

reply “Yes, we do.”¹⁷ The email was sent from Madison Reynolds at chelanbus4fun@gmail.com.

19. On January 30, 2024, I responded to the Company’s email and inquired what the cost would be for transportation service on May 10, 2024, for 10 people from the Grandview on the Lake hotel in Chelan, to various wineries in Chelan, Washington, and then returned to the Grandview on the Lake hotel in Chelan, Washington. On February 6, 2024, Chelan Wine Tours responded with a quote of “\$70 per person.”¹⁸
20. On February 7, 2024, I responded to the Company’s email asking to confirm the vehicle could accommodate a group of 10 and to book the date of May 10, 2024.¹⁹ On February 9, 2024, I received a reply stating “the vehicle is a ford excursion limo that fits up to 14 people” and “please go to chelanwinetoursandexcursions.com and book a tour through there.”²⁰
21. On February 22, 2024, I visited Chelan Wine Tours’ Facebook page, www.facebook.com/ChelanWineTours, which provided the address of Chelan, Washington; provided the phone number (509) 655-6187; listed the email address of chelanbus4fun@gmail.com; and provided the website address www.chelanwinetoursandexcursions.com.²¹
22. On February 28, 2024, I emailed DOL to confirm that there is no active limousine endorsement for Chelan Wine Tours. DOL responded the same day confirming there is no active endorsement.²²
23. Based on paragraphs 3 through 22 above, Commission staff finds that Chelan Wine Tours is operating as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.
