The purpose of this substitute filing is to add clarifying tariff language on Sheet No. 558-B about termination by customer. PSE also encloses a work paper with updated block labeling, as proposed in this filing, for the Monthly Rate Groups under the Energy Only Pricing Option and the Demand Only Pricing Option. These changes do not change any of the effective Schedule 558 rates that have been approved by the Commission on May 22, 2025.

The tariff sheets described herein reflect an issue date of August 5, 2025, and an effective date of September 4, 2025. Posting of the proposed tariff changes, as required by law and the Commission's rules and regulations, is being completed in accordance with WAC 480-100-193(1). No additional public notice is required under the provisions of WAC 480-100-194 or -195 as the proposed changes do not increase existing charges or restrict access to services.
