YOU MUST RESPOND WITHIN 15 DAYS OF THIS NOTICE

The Washington Utilities and Transportation Commission (Commission) believes that Dundee Concrete & Landscaping, LLC (Dundee or Company) violated Revised Code of Washington (RCW) 19.122.055(1)(a) by failing to notify the one-number locate service and causing damage to an underground gas facility.

RCW 19.122.055(1)(a) states, in part, that excavators who fail to notify a one-number locator service and cause damage to an underground gas facility are subject to a civil penalty of not more than \$10,000 for each violation.

Commission staff (Staff) conducted an investigation that included reviewing damage reports, investigation reports, the One Call Center database, and communications with the Company. The documents reviewed identified a natural gas event that involved Dundee damaging a natural gas facility while excavating without a valid locate ticket.

The Commission reviewed findings and recommendations made by Staff and hereby notifies you that it is assessing a \$1,000 penalty (Penalty Assessment) against you on the following grounds:

1. **Alleged Violation:**
On June 7, 2025, Dundee was excavating at 1108 W 15th Ave., Spokane, Washington. While excavating, Dundee workers struck and damaged an underground Avista Corporation (Avista) natural gas facility. The Damage Information Reporting Tool (DIRT) report submitted by Avista on July 2, 2025, indicated that Dundee was excavating without a valid request to locate underground utilities.
2. **Analysis:**
The alleged violation concerns RCW 19.122.055(1)(a), which states, in part, that an excavator must contact the one-number locate center before beginning excavation. The Gas Damage Report submitted by Avista identifies Dundee as the excavator responsible for

damaging a ½” gas service line. The report states that the excavator did not call for locates as it was unaware that grading a driveway was considered work requiring a locate request.

On August 22, 2025, Staff contacted Dundee and requested information regarding this damage incident. On August 25, 2025, Dundee returned a statement explaining there was not supposed to be excavation only removing an existing concrete driveway and pouring new over the existing grade. While grading, it hit a gas line that was not buried deep enough. Dundee acknowledged it should have requested locates even if it had not been planning to excavate.

The Commission considered the following factors in determining the appropriate penalty amount for the violation:

1. **How serious or harmful the violation(s) is/are to the public.**
This incident could have been harmful to Company workers, utility technicians, nearby homeowners, and the public, and could have resulted in serious injury and loss of property.
2. **Whether the violation(s) is/are intentional.**
This violation appears to be due to negligence by Dundee rather than a lack of knowledge regarding Washington State’s dig law. Over the last twelve months Dundee has submitted 34 requests to locate underground facilities in Washington. This demonstrates the Company’s knowledge of requirements and its responsibility to contact the one-number locate service before beginning excavation.
3. **Whether the company self-reported the violation(s).**
The Company did not self-report the violation. The Commission became aware of the violation when Avista filed a DIRT report following the damage incident.
4. **The likelihood of recurrence.**
The likelihood of recurrence depends on the Company’s actions going forward and its willingness to notify the one-call locate service every time prior to excavation.
5. **The Company’s previous violations and/or penalties.**
On November 16, 2016, the Commission mailed an Alleged Violation of Washington Dig Law letter to Dundee. The letter included detailed information about Washington State’s Underground Utility Damage Prevention Act, requirements for submitting utility locate requests before excavating, and the possibility of penalties for each violation. The Commission mailed the letter after receiving a report of damage caused by Dundee on September 8, 2016, that occurred because the Company failed to submit a request to locate underground utilities before excavating.

The Commission has considered these factors and determined that it should penalize Dundee Concrete and Landscaping, LLC as follows:

- \$1,000 penalty for one violation of RCW 19.122.055(1)(a) with an offer to suspend an \$800 portion of the penalty for one year, and then waive it, subject to the conditions that:

- 1) Company management and field crew responsible for excavation complete Dig Safe Training provided through the National Utility Contractors Association (NUCA) within 90 days of this Penalty Assessment;
- 2) The Company must submit documentation of training completion to the Commission; and
- 3) The Company must not commit any further violations of RCW 19.122 within 12 months of the date of this Penalty Assessment.

These facts, if proven at a hearing and not rebutted or explained, are sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe the violation(s) did not occur, you may deny committing the violation(s) and contest the penalty through evidence presented at a hearing or in writing. Or, if there is a reason for the violation(s) that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for a hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation(s) or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation(s) or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

You must act within 15 days after receiving this Penalty Assessment to do one of the following:

- Pay the \$1,000 penalty amount due; or
- Pay \$200 and notify the Commission that you accept the offer to suspend an \$800 portion of the penalty amount subject to the following conditions:
 - Company management and field crew responsible for excavation must complete NUCA Dig Safe Training (<https://utc-9183.quickbase.com/db/bpkt6vndh>) within 90 days of service of this Penalty Assessment; and
 - The Company must submit documentation of training completion (Certificate) to the Commission. (See attached **NUCA Dig Safe Training Verification Record**); and
 - The Company must not incur any additional violations of RCW 19.122 within 12 months of the date of this Penalty Assessment; or
- Request a hearing to contest the occurrence of the violation(s); or
- Request mitigation to reduce the amount of the penalty.

- [] 3. **Contest the violation(s).** I believe that the alleged violation(s) did not occur for the reasons I describe below (**if you do not include reasons supporting your contest here, your request will be denied**):
- [] a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.
- OR [] b) I ask for a Commission decision based solely on the information I provide above.
