GRANTING JOINT MOTION TO CONSOLIDATE PROCEEDINGS AND AMENDING PROCEDURAL SCHEDULE

BACKGROUND

On December 18, 2020, Northwest Natural Gas Company, d/b/a NW Natural, (NW Natural or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective Tariff WN U-6, Natural Gas Service.

The Commission suspended operation of the tariffs on January 7, 2021, by Order 01 in Docket UG-200994.

- Also on December 18, 2020, NW Natural filed with the Commission a Petition for an Accounting Order Authorizing Deferred Accounting for Certain Start-up Costs Associated with a Major Information Technology and Services Project (IT Petition) in Docket UG-200996.
- On January 19, 2021, the Commission convened a virtual prehearing conference in Docket UG-200994 and on January 26, 2021, the Commission issued a Prehearing Conference Order that, among other things, set various deadlines for filing testimony and established a date for an evidentiary hearing.
- 4 On February 8, 2021, NW Natural filed a Petition for an Accounting Order Authorizing Deferred Accounting Treatment of Conservation Potential Assessment Costs (Conservation Petition) in Docket UG-210085.
- On May 5, 2021, Commission staff (Staff) filed a Joint Motion to Consolidate Proceedings and the Amend Procedural Schedule (Joint Motion), on behalf of the Company, the Public Counsel Unit of the Attorney General's Office (Public Counsel), the Alliance of Western Energy Consumers (AWEC), and The Energy Project. (collectively, the Parties).
- In the Joint Motion, the Parties state that progress has been made towards a settlement in principle, and that consolidating the matters in Dockets UG-200996, UG-200994, and UG-210085 will assist the Parties with negotiating a potential settlement that resolves all three dockets. In light of this progress, the Parties request agreed changes to the procedural schedule relating to deadlines for filing testimony and exhibits.

DISCUSSION AND DECISION

- The Commission grants the Joint Motion and adopts the proposed amendments to the procedural schedule as reflected in Appendix A to this Order. Pursuant to Washington Administrative Code (WAC) 480-07-375, parties may request modifications to the procedural schedule. WAC 480-07-320 allows the Commission to consolidate proceedings in which the facts or principles of law are related.
- The Parties have demonstrated that NW Natural's proposed tariff revisions in Docket UG-200994 and the accounting petitions in Dockets UG-200996 and UG-210085 involve common issues of fact and law, *i.e.*, recovery of costs relating to specific projects.

The Parties have also demonstrated that the proposed modifications to the procedural schedule may facilitate the resolution of all three dockets by settlement. Accordingly, we conclude that granting the Joint Motion is consistent with the public interest.

ORDER

THE COMMISSION ORDERS THAT the Joint Motion to Consolidate Proceedings and Amend the Procedural Schedule is GRANTED. The revised procedural schedule is reflected in Appendix A, attached to, and incorporated into this Order by reference.
