SECOND NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS (Now due by 5 p.m. on Monday, November 29, 2021)

RE: Relating to the Commission's proceeding to develop a policy statement addressing alternatives to traditional cost of service rate making, Docket U-210590

TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) was informed by stakeholders that a Notice issued in above-referenced docket on October 11, 2021, was not properly distributed. Accordingly, the Commission issues this Second Notice to provide interested persons with additional time to file written comments. The full text of the original Notice appears below.

Beginning January 1, 2022, Revised Code of Washington (RCW) 80.28.425 requires electric and natural gas companies regulated by the Commission to include in each general rate case filing a multiyear rate plan (MYRP). The statute further requires the Commission to determine a set of performance measures that will be used to assess a utility operating under a MYRP.

To that end, the Legislature directed the Commission, in Section 1 of Engrossed Substitute Senate Bill 5295, 1 to conduct a proceeding to develop a policy statement addressing alternatives to traditional cost of service rate making, including performance-based measures or goals, targets, performance incentives, and penalty mechanisms. The Legislature further directed the Commission to consider a number of factors as part of such a proceeding, including, but not limited to, lowest reasonable cost planning, affordability, increases in energy burden, cost of service, customer satisfaction and engagement, service reliability, clean energy or renewable procurement, conservation acquisition, demand side management expansion, rate stability, timely execution of competitive procurement practices, attainment of state energy and emissions

reduction policies, rapid integration of renewable energy resources, and fair compensation of utility employees.

By January 1, 2022, the Commission must report to the Legislature on the progress of this proceeding to date, as well as its expected duration. The Commission must also provide the work plan associated with this proceeding.

The Commission is seeking public comments on its proposed Work Plan for this proceeding (Work Plan), attached to this Notice as Appendix A. As outlined in Appendix A, the Commission anticipates it will conduct this proceeding in multiple phases over several years. In Phase 1 of this proceeding, which the Commission anticipates will conclude in early 2023, the Commission intends to gather stakeholder input on the development of utility performance metrics.

The Work Plan provides a high-level overview of Phases 1 through 4, as well as a more detailed work plan for Phase 1. The Commission seeks comment on the specific scope and timing of the proposed Phase 1 work plan as well as the scope, timing, and overall phasing the Commission is proposing for this proceeding. The Commission expects significant discussion on the Work Plan and recognizes that the complexity of the issues raised in the statute may require it to revise the Work Plan during the process.

In addition to any general feedback stakeholders wish to offer on the attached Work Plan, the Commission is also seeking Stakeholder responses to the following questions:

- 1. Do you have any thoughts, concerns, or suggestions on the proposed scope or timing of Phase 1?
- 2. What are the most important issues for the Commission to address in Phase 1?
- 3. Do you have any thoughts, concerns, or suggestions on the overall Work Plan, including on the proposed scope or timing of Phases 1 through 4?
- 4. Are there additional topics the Commission should consider addressing, or any additional phases the commission should consider including in this Work Plan?
- 5. Do you have any other comments you would like to offer on the proposed Work Plan or on the development of policy under RCW 80.28.425 more generally?
