RE: Stevens County Solid Waste Management Plan Cost Assessment Questionnaire TG-210734

Dear Kevin Dionas:

The Washington Utilities and Transportation Commission (Commission) has completed its review of the cost assessment questionnaire for the preliminary draft of the Stevens County Comprehensive Solid and Moderate Risk Waste Management Plan (Plan) submitted on September 17, 2021.

The County's plan appropriately considers the County's rural location and relatively small population and has focused its recycling efforts on collection of commodities with viable markets, such as cardboard, while refusing to collect commodities with no current market value, like glass. The County also places an emphasis on the diversion of potentially harmful materials from its landfill, such as tires and Moderate Risk Waste, which includes auto batteries, used oil, and CFCs.

There is currently no residential recycling collection offered within the County. Instead, the County collects recyclables from its residents through various drop boxes located strategically throughout the County. The materials collected at these collection sites are hauled to the Community Recycling Center (CRC) facility where they are sorted, weighed, and bailed before being transported to market. As of July 1, 2021, the County has taken back operation and control of the CRC facility and County-owned transfer stations from Sunshine Disposal and Recycling. Now that the County is operating these facilities, it intends to gather more accurate data on the mix of recyclables and contaminates and implement changes to improve the efficiency and economics of the program.

The cost assessment questionnaire in the 2021-2026 Plan anticipates changes to tip fees at the Stevens County Landfill in 2023 and 2025. These anticipated tip fee increases are based on the County's best guess at the time the plan was drafted and are subject to change if necessary. If implemented as planned, there will be rate impacts to ratepayers served by regulated solid waste collection companies in Stevens County, as shown in the table below.
