- Pursuant to RCW 81.80.130, the Washington Utilities and Transportation Commission (Commission) has authority to regulate common carriers, including household goods carriers, with respect to safety of operations. WAC 480-15-450 provides that the Commission may cancel a household goods carrier's permit and operating authority for good cause, including where the carrier fails to comply with safety requirements. Commission staff (Staff) recommends that the Commission cancel the permit of Miracle Man Movers, LLC, (Miracle Man Movers or Company) for good cause due to the Company's ongoing failure to comply with applicable laws and Commission rules pertaining to the operation of household goods carriers, including safety requirements set in law or rule.
- WAC 480-15-999 adopts by reference Title 49 of the Code of Federal Regulations (C.F.R.), pertaining to safety requirements for household goods carriers. WAC 480-15-560 specifically requires carriers to comply with 49 C.F.R. Part 385.49. Additionally, 49 C.F.R. § 385.13 prohibits motor carriers from operating beginning on the 61st day after the date of a notice of proposed unsatisfactory rating. Pursuant to 49 C.F.R. § 385.17, a carrier that receives a proposed unsatisfactory or conditional safety rating may request a change in its safety rating based on evidence that the company has taken corrective actions to address the identified violations and that the company's operations currently meet the safety fitness standards.
- *3* On December 20, 2019, the Commission granted the Company a provisional household goods carrier permit THG068778.
- 4 On February 22, 2021, Staff completed an investigation of the Company's compliance with the safety requirements in WAC 480-15. As a result of the compliance investigation, Staff documented 77 safety requirement violations and proposed a conditional safety rating for the Company.

- 5 On March 8, 2021, the Commission issued a Notice of Intent to Cancel Permit as a Household Goods Carrier and a Notice of Brief Adjudicative Proceeding in Docket TV-210128, setting the brief adjudicative proceeding (BAP) for April 15, 2021, at 9:30 a.m.
- 6 On April 14, 2021, Staff informed the presiding officer in Docket TV-210128 that the Company had submitted to Staff a proposed safety management plan. Staff evaluated the proposed plan and determined it is acceptable. Staff recommended that the Commission cancel the BAP and enter an order addressing the Company's safety rating based on the evidence in the record. The Company also waived its right to the hearing in that docket. That same day, the Commission issued a notice indicating that good cause existed to cancel the BAP set for April 15, 2021.
- 7 On April 19, 2021, The Commission issued Order 01 in Docket TV-210128. In Order 01, the Commission approved the Company's safety management plan, maintained its safety fitness rating at conditional status, and extended the Company's provisional period until such time as the Company achieved a satisfactory safety rating.
- 8 On June 29, 2022, Staff completed a follow-up investigation of the Company's compliance with the safety requirements in WAC 480-15. As a result of the follow-up compliance investigation, Staff documented 261 safety requirement violations and proposed an unsatisfactory safety rating for the Company. Staff notified the Company of this proposed rating on June 29, 2022.
- 9 Miracle Man Movers must come into compliance with applicable laws by obtaining Commission approval of a safety management plan no later than August 26, 2022. If the Company fails to come into compliance by that date, the Commission will cancel its household goods carrier permit effective August 29, 2022. Thereafter, as an unregistered company, Miracle Man Movers would be prohibited from providing household goods carrier service in the state of Washington.
- 10 THE COMMISSION GIVES NOTICE: That it intends to cancel the permit and authority of Miracle Man Movers to provide services as a household goods carrier effective August 29, 2022, for cause, following a hearing on the factual allegations set out above, unless the Company obtains Commission approval of a safety management plan prior to that date.
- 11 The Company has the right to request a hearing in this matter. Due to the short timeframe determined by the upcoming deadline, and pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission schedules a hearing on its own initiative and determines that a brief adjudicative proceeding is appropriate to determine whether the Commission should cancel Miracle Man Movers' provisional household goods carrier permit.

- 12 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
- 13 Written notice of any other stage in the proceeding or other formal proceedings that the Commission may deem appropriate will be given during the course of this case. The Commission will provide on its website copies of documents in the current record for use by the parties or others who may want to review them.
- 14 Miracle Man Movers must submit its proposed safety management plan no later than 5 p.m. on July 29, 2022. Parties wishing to submit any other documents for consideration at the brief adjudicative proceeding must file with the Commission a list enumerating and describing any such documents no later than 5 p.m. on August 5, 2022, and email copies of those documents to the other parties and the presiding officer by 5 p.m. on August 5, 2022. Filing shall be in accordance with WAC 480-07-140.
- 15 THE COMMISSION GIVES NOTICE: That any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.
