Dear Jeff Killip,

The company is filing for a new tariff and updating rates. The company is removing the surcharge requirement and updating rates to reflect the cost of providing water to the customers. This increase just covers the increased cost of doing business for the system. The company revenue impact of this filing, based on a 2023 test year, will be an increase of \$89,000 dollars or approximately 13.4%. If approved, the average bill will increase by approximately \$13.00 (21%) per month for average users starting May 1, 2024. The rate impact is presented below:
