

## Integration Addendum (Standard Support)

This addendum is between the customer referenced in the signature block below or electronically signing hereto ("Subscriber") and whichever of HireRight, LLC or General Information Solutions LLC has an existing services agreement ("HireRight") governing HireRight's provision of background screening services to Subscriber (the "Agreement"). This addendum comes into effect when signed by the later of HireRight or Subscriber. This addendum will stay in effect as long as the Agreement is in effect. This addendum incorporates the provisions set out in this addendum into the Agreement. This addendum supplements the Agreement between the parties and does not modify, amend, or delete any existing term therein except as expressly set forth in this addendum. This addendum must be interpreted with the existing Agreement to form one agreement.
