Chad,

Line splitting and line sharing were reported as a separate product categories in September 2003, reflecting August results. In service line counts were separated between line sharing and line splitting in the September results reported in October . Up until this point in time, line splitting lines would have been grouped with line sharing and reported as such. Qwest has subsequently discovered that in line splitting situations, where MCImetro is the underlying carrier and Rhythms is the data provider, it had incorrectly identified the underlying carrier as Rhythms. This is being addressed and Qwest anticipates a correction with November results due in December.

Additionally, Qwest has discovered a small number of records identified in the September performance report as line sharing and incorrectly belonging to MCImetro. This can happen when the order is written without the proper FIDs that indicate line splitting. In this event, the record was bucketed as line sharing instead of line splittling. These records will be corrected with the December results due in January.

Steve,

As discussed, I am confused on the performance reporting that we are getting. Per the attached comments you will see that Qwest has stated "*Qwest had identified a problem which was being corrected and that line splitting would be reported as a separate product category in the CLEC specific performance results reports for September 2003, and would also reflect August 2003 historical results, if any. The problem has been corrected. CLEC specific performance results reports for September performance reflect line splitting as a separate product category from line sharing for PIDs OP-3, OP-4, OP-5, OP-6, MR-3, MR-6, MR-7 and MR-8, as well as reflect August historical data and the issue should be considered closed*".

However, as briefly discussed, under the Colorado September reporting I see no Line Splitting results for the OP measures under MCI metro which is where I would expect these orders to be tracked given that MCI M02 is the customer of record. I do however see reporting under MCI metro for Line Sharing (?) and Line Splitting for the MR measures. However, if I look under Rhythms (A16) reporting I see reporting for the OP measures for Line Sharing and Line Splitting (?) and then only MR reporting for Line Sharing only.

Generally we order Line Sharing under Rhythms (A16) and Line Splitting under MCI (M02). So, the main question is why would Line Splitting be showing up under Rhythms (A16) reporting when we order under MCI Metro (M02)? I would also generally expect to see Line Sharing reporting under Rhythms, so not sure why we see Line Sharing reporting for MR measures under MCI (M02) in addition to Rhythms (A16).
