## COMMERCIAL CAN RATE AND SERVICE CHANGE NOTIFICATION

Dear Customer:

January 31, 2017

Murrey's Disposal Co., Inc. is excited to announce that we are automating our residential, multi-family can and commercial can routes. Beginning March 1, 2017 we will be providing customers with wheeled garbage carts to replace manually serviced customer provided cans. This program improvement will help alleviate employee injuries and offer a better service package to our customers.

We have filed a request for approval of this new program with the Washington Utilities and Transportation Commission (WUTC) to recover the capital investment, and other costs required for this new program. The last general rate increase was approved by the WUTC June 1, 2016.

Cart delivery will start March 1, 2017 and continue through June 30, 2017. Upon receipt of the company provided cart you will be required to transition to cart service and discontinue use of your can. If your current service is 1-20 gallon can you will receive 1-20 gallon cart; if your current service is 1-32 gallon can you will receive 1-35 gallon cart; if your current service is 2-32 gallon cans you will receive 1-64 gallon cart; if your current service is 3-32 gallon cans, or more, you will receive 1-95 gallon cart. You will be able to change your cart size once after delivery of your initial cart. Any additional size changes may result in a redelivery fee.

If the new program is approved, the proposed rates below will become effective March 1, 2017. The new rate will be applied the first pickup of the next month after the cart is delivered to your service address. The rates below include the cost of the new program, including the cost of your cart.

\* These rates are currently under review at the Commission and reflect an increase related to the Pierce County disposal fee increase effective March 1, 2017. Your bill will reflect these can rates until the first full month after you receive your new cart, at which time you will be charged the new cart rates.
