In accordance with WAC 480-07-640, Company A requests approval of the fully negotiated amendment to an interconnection agreement, as described below:

Amendment Number: 9

Description of amendment: This amendment adds terms, conditions and rates for Collocation Transfer of Responsibility, as set forth in Attachment 1 and Exhibit A, attached hereto and incorporated herein.

The amendment amends the interconnection agreement first accepted by the Commission on March 10, 1999 in WUTC Docket No. UT-990313 between U.S. West Communications, Inc. (nka Qwest Corporation) and Focal Communications Corp. of Washington (nka Broadwing Communications, LLC)). That agreement was first approved by the Commission on April 23, 1997 between Electric Lightwave, Inc. and U.S. West Communications, Inc. in Docket No. UT-960337.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
