ORDERED, ADJUDGED AND DECREED THAT:

Order 08, Final Order Approving and Adopting Multi-Party

Settlement Stipulation and Requiring Compliance Filing, issued by the

Washington Utilities and Transportation Commission on December 29,

2008, is AFFIRMED in all respects, as it is consistent with the law and
agency rules, and supported by substantial evidence, except for two items:

The Court REVERSES the Commission's decision allowing inclusion of
sporting events and entertainment costs (\$68,131), and charitable donations

(\$23,953), in Avista's revenue requirement, as based on erroneous
interpretation and application of law, and REMANDS these items for further
relief consistent herewith.
