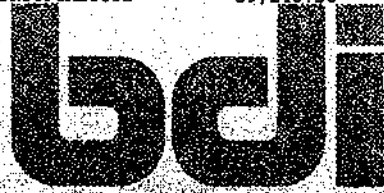

Buyer, by signing this Agreement, acknowledges that Buyer has read its terms and has received a true copy of this Agreement.
