Dear Mr. McLellan:

Cascade Natural Gas Corporation ("Cascade") encloses for filing the following tariff sheets containing a requested effective date of August 1, 1997:

The purpose of this filing is to reflect the \$1.00 per month increase in core customer service charges and the corresponding decrease in Rate Schedule Nos. 663 & 664 transportation rates pursuant to the rate spread portion of the Settlement Agreement that was approved by this Commission in its Fourth Supplemental Order in Docket No. UG-951415. Cascade examined the twelve months ended May 31, 1997 and determined that, based upon the number of core customers it had in that period, an increase of \$1.00 per month in the customer service charge would result in an additional \$1,520,514. The Company next examined its deliveries to customers served on Rate Schedule Nos. 663 & 664 during that same period and applied the decrease in rates per rate block that was estimated and included as part of the Settlement Agreement and found that those estimated rates would have produced a reduction of \$1,591,932, which is 95.51% accurate. In compliance with the Settlement Agreement, the reductions per rate block were adjusted proportionately such that the attached 663 & 664 rate schedules to produce a decrease of \$1,520,583, which is within \$70.00 of the required \$1,520,514.

Washington Service Area

Cascade Natural Gas Corporation is on this date filing with the Washington Utilities & Transportation Commission (WUTC) at Olympia, Washington, revision in its Washington service area tariffs consistent with the settlement of Cascade's 1996 general rate case. Upon approval by the Commission, these revisions will become effective August 1, 1997.

The purpose of this filing is to reflect the \$1.00 per month increase in core customer service charges and the corresponding decrease in Rate Schedule Nos. 663 & 664 transportation rates pursuant to the rate spread portion of the Settlement Agreement that was approved by the WUTC in its Fourth Supplemental Order in Docket No. UG-951415.

The effect of this filing will be an increase of \$1.00 per month for all of the residential, commercial and industrial core rate schedules. Transportation rate schedules 663 & 664 will decrease by an average of 10.1%. The amount of increased revenue from the monthly customer service charge is offset by the decrease in transportation rates such that the earnings of Cascade will not change.

A copy of the proposed tariffs is available for inspection in each of Cascade's business offices in the State of Washington.

The purpose of this filing is to reflect the \$1.00 per month increase in core customer service charges and the corresponding decrease in Rate Schedule Nos. 663 & 664 transportation rates pursuant to the rate spread portion of the Settlement Agreement that was approved by this Commission in its Fourth Supplemental Order in Docket No. UG-951415. Cascade examined the twelve months ended May 31, 1997 and determined that, based upon the number of core customers it had in that period, an increase of \$1.00 per month in the customer service charge would result in an additional \$1,520,514. The Company next examined its deliveries to customers served on Rate Schedule Nos. 663 & 664 during that same period and applied the decrease in rates per rate block that was estimated and included as part of the Settlement Agreement and found that those estimated rates would have produced a reduction of \$1,591,932, which is 95.51% accurate. In compliance with the Settlement Agreement, the reductions per rate block were adjusted proportionately such that the attached 663 & 664 rate schedules to produce a decrease of \$1,520,583, which is within \$70.00 of the required \$1,520,514.

This unbundled distribution system transportation service schedule is available throughout the territory served by the Company under the tariff of which this schedule is a part, provided, in the sole judgment of the Company, there are adequate facilities in place at the existing distribution line or as such line may be enhanced by the Company from time to time to provide service. Service under this schedule shall be in conjunction with service provided under optional gas supply supplemental Schedule Nos. 681, 682, 683, or 684 and shall be in conjunction with service provided under optional pipeline capacity supplemental Schedule Nos. 685 or 686. In the absence of customer's specification of firm or interruptible pipeline capacity service under Schedule No. 685 or No. 686, customer shall be billed at the rates then in effect under Schedule No. 686.

ANNUAL MINIMUM QUANTITY AND ANNUAL MINIMUM BILL:

Customers must consume a minimum of 2,400,000 metered therms annually to be served under this schedule. Existing customers must show a history of the most recent 12 months of consuming the 2,400,000 annual minimum therm requirement or must demonstrate enough newly connected gas equipment such that the total consumption will meet or exceed the 2,400,000 annual minimum therm requirement to qualify for this schedule. New customers must clearly demonstrate their annual therm consumption will be greater than the 2,400,000 therm annual minimum consumption requirement to qualify for this schedule. The annual minimum quantity stated in a customer's contract served under this schedule will be negotiated, but in no event be less than 2,400,000 therms.

If a customer does not consume a minimum of 2,400,000 therms annually (twelve months ending on the customer's contract anniversary date) the customer will pay for the deficiency balance of the 2,400,000 therms not used as though the deficiency therms were consumed in the twelth month of the contract year. If such an annual minimum deficiency occurs due to force majeure or low product demand conditions, in the sole judgement of the company, the customer may be required to shift to another qualifying schedule to receive distribution service. If such an annual minimum deficiency occurs absent of force majeure or low product demand conditions, the customer will be required to shift to another qualifying schedule to receive distribution service.

RATE:

A. Dispatching Service Charge All therms delivered
